Name of the Post:

Item No. 1 : 1 (one) post of Chairperson

Item No. 2 : 2 (two) posts of members

Eligibility Criteria:

- a. The applicant should have a degree from any recognized university as his/her minimum educational qualification.
- b. The applicant should have previous experience relating to the following subjects:-
 - i. Education
 - ii. Child Health, Care, Welfare or Child Development
 - iii. Juvenile Justice and Care/elimination of child labor
 - iv. Child psychology or Sociology
 - v. Laws relating to children
- c. The applicant should not be a Member of Parliament/State Legislature and should not hold any office of Trust or Profit or be connected with any political party – or if connected with any political party, sever his/her connection with the party.
- d. The applicant should not have any past record of violation of human rights or child rights.
- e. The applicant should not have been convicted and sentenced for imprisonment for an offence which in the opinion of the state government involves moral turpitude.

Tenure:

Item No. 1 : The Chairperson shall, unless removed from office under Sec 7 of the Commission for Protection of Child Rights Act, 2005, hold office for a period of 3 years or till the age of 65 years, whichever is earlier.

Item No. 2 : The member shall, unless removed from office under Sec 7 of the Commission for Protection of Child Rights Act, 2005, hold office for a period of 3 years or till the age of 60 years, whichever is earlier.

Honorarium:

Item No. 1 : Rs. 25, 000/- P.M

Item No. 2 : Rs. 10,000/- P.M
