NLA COMPLEX DECLARED RESTRICTED AREA

In pursuance to the notification, the Speaker, Nagaland Legislative Assembly has demarcated the entire area inside the Main Gate (near NPSC Office) including the Assembly Quarters area as High Security Zone and entry restricted which prohibits picnicking, gathering, loitering and littering in the High Security Zone with immediate effect.

AWAN KONYAK APPOINTED AS CHAIRPERSON OF NSCPCR

Commissioner & Secretary, Social Welfare Department, O. T. CHANGE IN AGE CRITERIA FOR ADMISSION IN SAINIK SCHOOLS

The Executive Committee of Sainik Schools under the chairmanship of Defence Secretary held a meeting on 15th December 2017 whereby they have approved the change in the age criteria for admission to Sainik schools - Age should be 10-12 years for Class VI and 13-15 years for Class IX as on 31st March of the year in which admission is sought. The course of Foundation in Financial Management (FFM) has been designed by NSE Academy to familiarize students about the basics of financial markets, financial statements, working of mutual funds and capital markets.

Civil Service is an opportunity to change the lives of people: Dr. D. Bhalla

Inaugural programme for the common induction of IAS, IPS & Allied Services (2017 batch) and NCS, NPS & Allied Services (2018 batch) was held on 1st June 2018 at Multipurpose Hall, ATI, Kohima.

'Change cannot happen overnight, it takes time and happens gradually,' said ATI Director General, Dr. D Bhalla IAS while addressing the trainees at ATI. He said that when he was the Director of ATI, the training for NCS probationers was extended to one year full-fledged course similar to Indian Administrative Service which is a federal service and serve at the grass root level in some states and then go back to the center to provide policy inputs.

WORLD ENVIRONMENT DAY CELEBRATED ACROSS THE STATE

KOHIMA:

Kohima celebrated 'World Environment Day' on June 5th 2018 at NBCC Convention Centre under the theme 'Beat Plastic Pollution (If you can't reuse it, refuse it),' organized by the Department of Environment, Forests & Climate Change.

Extending greetings on World Environment Day, Chief Minister Rio said the day is being observed to reinforce our commitment in protecting the environment for a better future for all of us. He stated that World Environment Day is the "people's day" for doing something to take care of the Earth and which can be focused locally, nationally or globally, solo action or can involve everyone.

Promising to launch a campaign for Clean & Green Nagaland within three months. Rio added that the government is committed to planting trees for a Green Nagaland. He called upon the youth and the people of the State to join this campaign and plant more trees for a Greener Nagaland. He said that the dream of a Clean and Green Nagaland will be a reality only with active participation of everyone. Plastics has become a municipal waste nightmare, prompting local governments all over the world to implement ban on use of plastic bags and he stated that countries like Bangladesh, France and Rwanda have duly banned plastic bags. World Environment Day provides an opportunity for each of us to adopt many lifestyle changes that can help combat plastic pollution and we need to act actively and participate willingly to combat this challenge and save our fragile environment.

Rio said that the KMC is implementing the Plastic Waste (Management & Handling) Rules 2011 under The Environment Protection Act, 1986, however, he said that there is need to improve awareness as well as enforcement of the act. He urged all to stop using plastic bags and instead take reusable cloth bags for shopping, Minister, EF&CC and Parliamentary Affairs, C.M. Chang, in his keynote address, said the celebration of the day is a call for action to everyone to come together and combat one of the greatest environmental challenges of our time. He added that plastic has many valuable uses, and we have become over-reliant on single-use or disposable plastic and this impending epidemic is overwhelming our planet. We are addicted to the convenience of single-use plastic starting from the single-use plastic water bottle, take-away coffee cup, lunch wrapped in disposable plastic packaging, and possibly a plastic bag.

In collaboration with Department of EF&CC, Nagaland Science & Technology Council launched a book on School Tool Kit on the World Environment Day. The kit contains a Teacher's Hand Book, three posters, booklet for students on positive hand print action. The kit seeks to inculcate a sense of responsibility in schoolgoing children and motivate them to reduce, reuse and recycle plastic by their individual action. The Teacher Manual developed, as a part of the kit, provides teachers an opportunity to meaningfully engage with students to clarify facts associated with the increasing plastic pollution. 100 copies of the Tool Kit will be distributed to schools and government departments.

The programme was chaired by Secretary, EF&CC, Imtienla Ao. Invocation was pronounced by Youth Secretary, Co-convener, NBCC Sanitation & Environment Committee, Rev. Vikuo Rhi. Other highlight of the programme included short play by Dreams Unlimited and Green Pledge was read out by the Speaker, Nagaland Legislative Assembly, Vikho-o Yhoshu. The CM felicitated the winners

of the state level poster competition for school students below standard X. Winners of 1st, 2nd and 3rd positions were bagged by Marnungba, Class IX, Town Higher Secondary School, Mokokchung, Pipito Awomi, Class X, Holy Family Higher Secondary School, Kohima, Atuna Shikhu, Class X, North field, Kohima. Departmental Book was released by the Chief Minister, followed by the inauguration of photo exhibition. All the participants were given a tree sapling to commemorate the World Environment Day.

STATE CABINET HOLDS MEETING

The State Cabinet in its meeting held on June 5th 2018 took the following decisions:

- The Cabinet discussed its 16th April 2018 decision on the constitution of Nagaland Investment and Development Authority (NIDA) and approved the change in nomenclature to Investment and Development Authority Nagaland (IDAN) to avoid confusion with similar sounding acronym.
- The Cabinet has decided to constitute a Committee to study the issues relating to royalty collection on minor minerals between the Forest Department and Geology & Mining Department and amendment thereof. The Committee shall comprise of the following:
 - (i) Sentiyanger Imchen IAS, Principal Secretary, Municipal Affairs & Development Commissioner: Chairman
 - (ii) Principal Secretary, Environment, Forest and Climate Change: Member
 - (iii) Commissioner & Secretary, Geology & Mining: Member
 - (iv) PCCF, Nagaland: Member
 - (v) Director, Geology & Mining, Nagaland: Member
 - (vi) Secretary, Law & Justice Department: Member
- Advocate General, Nagaland apprised the Cabinet on various matters of importance pending before the Supreme Court and the High Court. It decided to constitute a Ministerial Committee to examine the Women Reservation issue and hold discussions with the Tribal Hohos and all other stakeholders. The Committee shall consist of:
 - (i) G. Kaito Aye, Minister : Convener
 - (ii) C.M. Chang, Minister: Member
 - (iii) Neiba Kronu, Minister : Member

- (iv) P. Paiwang Konyak, Minister: Member
- (v) Jacob Zhimomi, Minister: Member
- (vi) Mmhonlumo Kikon, Advisor : Member
- The proposed Citizenship Amendment Bill of the Government of India was also discussed. The Cabinet is of the view that Nagaland is protected under Article 371(A) of the Constitution and the ILP Regulations. However, if the proposed amendment goes against the interests of the Nagas, the Government of Nagaland will go against such amendments and take up any such issues with the Government of India.
- As a follow up to the meeting of the Political Affairs Committee meeting with Tribal Hohos dated 11th May, 2018 at Kohima, the Cabinet Secretary has been directed to write to the Nagaland Legislative Assembly for revival/ reconstitution of the Joint Legislators' Forum in order to strengthen the efforts being made towards the peace process.
- The Cabinet further decided that while Statehood Day will be celebrated on December 1st at the Secretariat Plaza, the inauguration of the Hornbill Festival will be held in the afternoon of 1st December. Garo, Kachari and Kuki communities will also be included for the Mini Hornbill and for Dimapur District, Naga Council Dimapur can organize a common function of all tribes in consultation with the Deputy Commissioner and Tribal Bodies. Further, Mini Hornbill festivals will be held in the districts as decided by the Cabinet in its earlier meeting dated 16th April 2018.
- The Cabinet discussed and reviewed its 7. earlier decision dated 8th March 2018 and decided to revoke the renaming of Indira Gandhi Stadium to Dr. T. Ao Stadium.

REVIEW MEETING OF NEC PROJECTS AT KOHIMA

A review meeting was held with the Secretary, DoNER, Naveen Verma and Secretary, NEC, Ram Muivah IAS with various departments at the Secretariat Conference Hall. Kohima on 8th June 2018.

WORKSHOP ON OPERATIONALISATION OF HEALTH & WELLNESS CENTRES

Commissioner & Secretary, Health & Family Welfare, I. Himato Zhimomi called upon the Health Service Provider in the state for a newer and holistic approach on health issues, he was addressing district and state officials of the Department of H&FW during a one-day State level Orientation Workshop on the Operationalisation of Health & Wellness Centre (HWCs) under Ayushman Bharat initiative on the 8th of June 2018, at the Conference Hall of Hotel Vivor, Kohima. Himato emphasized on the emerging need of introduction on concept of wellness apart from health. He also envisaged concentrated efforts to be made towards improvement of mental, social and spiritual well-being of the society which in turn will improve the economic productivity and quality of life for the Naga people.

Dr. Kevichusa, Mission Director, NHM also reiterated on the need for continuum of care for chronic NCD diseases beside the RMNCH+A services. He urged all the officials present to support the initiative for successful implementation of HWCs.

The workshop was conducted by the department in collaboration with Developmental Partner Jhpiego- a non-profit global health leader affiliated with the Johns Hopkins University that works towards saving lives, improving health and transforming futures. Through this workshop, the state aims to roll out Comprehensive Primary Health Care (CPHC) services through up-gradation of existing health facilities into HWCs across the state.

In the first phase of implementation, the State Government of Nagaland would be upgrading 56 sub-centres to HWCs and not only that Government of India has selected two PHCs in Kiphire among the 115 Aspirational Districts in the country to be activated as HWCs and all the five Urban PHCs will also be upgraded to HWCs in the state.

The workshop touched upon the key elements of CPHC and HWCs, ensuring continuum of care; providing an expanded service delivery; expanding diagnostics and new technologies; promoting health through community mobilization; creating robust IT systems and partnering for knowledge. These centres will be equipped with a specialized team including a specially qualified Mid-Level Provider and other health workers who will be trained with additional multiple skills for efficient healthcare delivery. The Mid-Level Providers will be trained through a six month bridge course developed by IGNOU.

NATIONWIDE MILK SURVEY

Joint Director & SPO(FSSA), Dr. Akuo Sorhie stated that Food Safety and Standards Authority of India (FSSAI), which is conducting the national milk quality survey across India, has selected Kohima, Dimapur as sample collection spots for Nagaland.

A team of Hyderabad-based Vimta laboratory, appointed by FSSAI arrived in Kohima on 12th June 2018 and collected samples from various sources.

They checked the milk quality along with the

amount of adulterant, antibiotics, pesticide. The study will reveal the quality of milk of the state. The quality survey has been carried out by FSSAI independently and the state supports them with mobile lab, food safety personnel and sample collection.

The samples were collected from collection unit, milk plant, retailers from various part of Kohima. The survey continued in Dimapur from 13th June 2018. The samples will be sent to FSSAI laboratory for analysis.

STATE CABINET CALLS ON UNION MINISTERS

Chief Minister, Neiphiu Rio met the Union Minister for Road Transport and Highways, Shipping Water Resources, River Development and Ganga Rejuvenation, Nitin Gadkari at New Delhi on 13th June 2018.

The monitoring team for Integrated Catchment Area Treatment (ICAT) funded by the Ministry of Water Resources, River Development & Ganga Rejuvenation under the Flood Management Programme and implemented by the department of S&WC was conducted from 8th June to 12th June 2018 with visiting officials.

The newsletter narrates the process of implementation of Flood Management Program through Integrated Catchment Area Treatment in the upper Sidzu to trap the top fertile soil and surface runoff with various soil & water conservation measures i.e. water harvesting ponds, contour trenches, check dams, creation of nurseries & gap plantation, land shaping, contour bunds, sediment monitoring station, entry point activities etc. along with impressive meaningful photographs.

Pangnyu Phom signed the MoU with the Union Minister of Health & Family Welfare, Gol, JP Nadda on 14th June 2018 at New Delhi for implementation of the Ayushman Bharat National Health Protection Mission (AB-NHPM) in Nagaland, wherein those deprived families featuring in the SECC 2011 and existing beneficiaries under RBSY will be entitled for cashless health insurance coverage of Rs. 5.00 lakh per family through Empanelled Health Care Providers across the country.

Tovihoto Ayemi calls on Union Minister

Tovihoto Ayemi, MLA and Advisor (Power) along with senior officers from the Department of Power presented the technical requirements of the state to R. K. Singh, Union Minister of State for Power and New Renewable Energy at New Delhi on 15th June 2018.

The Advisor had pointed out that the power sector in the state has been ignored for so many years and there is a need to revamp and modernize this sector and for that, the state resources alone is insufficient to bring quick changes. He informed the Union Minister that the state has identified various hydro potential locations but there are numerous challenges in development of hydro projects and one such reason is attributed to adequate funding pattern from the Government of India and thereby requiring gap funding support from NEC/DoNER. He had submitted a letter from Chief Minister requesting the Union Minister to provide funding for few priority hydro projects in the state such as 42 Mega Watt Lower Tizu project, 24 Mega Watt Zungki project and 2.1 Mega Watt Dzuna experimental model project. While mentioning that the hydro project cost need to be thoroughly examined through appropriate central agency, the Union Minister gave assurance that necessary support will be extended.

Tovihoto Avemi also mentioned that conversion of the existing electro-mechanical meters to prepaid meters is the only solution to mitigate huge Aggregate Technical & Commercial (AT&C) loss of the state and he appealed to the Union Minister to request DoNER Ministry to speed up the proposed pre-paid project covering 19 statutory and census towns.

The Union Minister mentioned that although the AT&C loss in the state is now showing positive sign of improvement, the huge revenue loss has to be quickly controlled in important towns like Dimapur by engaging various stakeholders. He mentioned categorically that to quickly improve the power system, the State of Nagaland should no longer function in isolation with very outdated system and it is high time that like other North Eastern States, the power sector in the state should also be immediately corporatized so as to enable the state to avail various benefits from financial institutions.

Toshi Wungtong addresses Photography Training, releases booklets on "Important Schemes for Welfare of Citizens"

The two day training on skill upgradation on photography concluded with Advisor, SCERT, Information & Public Relations and Village Guards, Toshi Wungtong gracing the valedictory programme at DIPR Conference Hall, Kohima on 15th June 2018.

Photography is a powerful language as it can convey things around you, thoughts and unspoken languages, said Advisor Toshi Wungtong, exhorting the participants at the valedictory programme. STATE MEASLES AND RUBELLA VACCINATION CAMPAIGN WORKSHOP AT KOHIMA

A three day programme for the State Measles and Rubella Vaccination Campaign workshop and training of trainers started on 18th June 2018 at Hotel De Oriental Grand, Kohima with Commissioner & Secretary, Heath & Family Welfare, I. Himato Zhimomi as the Guest Speaker at the inaugural along with a host of other officials from WHO, UNICEF, Lions Club, officials representing from Nagaland Government and UNDP.

Himato Zhimomi in his opening remarks mentioned that the department will ensure that no child is left without immunization. He sought cooperation from the church, NGOs and appealed to all the trainers to take the workshop seriously as they will be the one who will be working at field level. He also urged the doctors especially in the border areas to tackle and prevent the spread of the disease as there are many international border areas where the movement from the other countries like Myanmar goes without much restriction.

Director, H&FW, Dr. Vikiye Medikhru in his opening remarks informed that India is committed to eliminate measles and to control Rubella and

Congenital Rubella Syndrome (CRS) by 2020 and added that to achieve this goal, Measles and Rubella (MR) campaign is being launched in the country covering all children from 9 months to below 15 years age group and mentioned that both diseases can only be prevented through vaccination. He informed the gathering that this campaign will be the largest ever MR campaign launched in the world and about 41 crore children in India will be covered under this campaign. The Director stated that Nagaland has decided to vaccinate the children of the state: it has an estimate target population of around 7 lakhs. He added that this is a one-time campaign and 35% population of the state and 2/3 of the target beneficiaries are school going children, hence he sought the participation and cooperation of all government, private schools.

State Expanded Programme Immunization Officer, Dr. Kobunuo highlighted the objectives and methodology of the campaign which is to train and orient key state and district programme managers on all operational components for planning and implementing the MR vaccination and prepare a poll of master trainers for conducting district workshop

and to train all the medical officers in the state.

A powerpoint presentation on broad understanding of the MR campaign strategy was presented by (Imm) MoHFW, Government of India, Dr. Phaldar. Team Lead, East, WHO India, Dr. Debasish Roy was the chairperson of the inaugural programme. Altogether 71 doctors of Directorate of H&FW and officials from other departments attended the three day programme.

The Committee on Government Assurances were briefed that although the initial work order was issued on 16.02.2010, due to various reasons like objection from BRO, Court cases etc. the work could be resumed only in the year 2017 with the following works under progress (1) Pile foundation three piers completed (2) Cable Suspension Bridge completed (3) Retaining wall almost completed (4) Reconstruction of two pile caps completed (5) Three mid piers completed (6) Piling work for the abutment wall completed. It has been made to understand that the bridge will be completed by December 2019.

The Committee verified the spot and was satisfied and encouraged the department to give all out efforts to complete the project within the stipulated time of December 2019. The Committee requested the department to endeavour implement its observation the requirement of:

- Strengthening the Cable Suspension Bridge for pedestrian safety or restrict usage completely.
- ii. Enhance the river training from 50m to alteast 200m.

Patton further stated that the drug abuse is not only illicit but also illegal and the term of imprisonment may even extend upto 10 years. She also stated that the day is not a day to celebrate but to join hands and fight against the social evils of drug uses and trafficking.

He lamented that however, they are subjected to social, physical, mental and economical abuse by their own family members. Highlighting that a secular law which applies across all religion and section of the society under section 125 to 128 CrPc for welfare of the senior citizens, Meribemo Lotha further said that the section enables the father or mother, who is unable to maintain himself or herself to claim maintenance from their sons or daughters if they refuse or neglect to maintain their parents.

Informing on Old Age Pension Scheme, Nribemo Shitiri, Senior H.A and Zubemo Jami, Senior Welfare Inspector, Social Welfare Department apprised that as per the scheme, every eligible senior citizen is entitled for the benefit but due to constraints of funds from the government, many beneficiaries could not avail the benefits from the scheme.

INTENSIFIED DIARRHOEA CONTROL **FORTNIGHT (IDCF) 2018**

Reduction of childhood mortality is one of the prime goals of National Health Mission and Millennium Development Goals. Childhood diarrhoeal disease continues to be one of the major killers among under-five children in many states contributing to 11 percent of underfive deaths in the country. Around two lakh children die due to diarrhoea annually in the country. Diarrhoeal deaths are usually clustered in summer and monsoon months. The worst affected are malnourished children and children under two years of age. To effectively address the issue, Intensified Diarrhoea Control Fortnight (IDCF) was implemented in 2014, with the aim of achieving improved coverage of essential lifesaving commodities like ORS and zinc dispersible tablets and practice of appropriate child feeding practices during diarrhoea, IDCF also focuses on the preventive aspects like sanitation and hand washing. The state held the annual IDCF from 12th June to 24th June 2018, with the ultimate aim of achieving zero child deaths due to diarrhoea. As per NFHS-4, the usage of a life saving commodity like ORS during diarrhoeal episodes in the state is only 43.5 % in urban and 40.8% in rural areas respectively.

What is Diarrhoea and how can it be prevented?

Diarrhoea is considered when the stools have changed from usual pattern and are many and watery (more water than faecal matter). Almost all the deaths due to diarrhoea can be averted by preventing and treating dehydration by the use of ORS (Oral Rehydration Solution) and administration of Zinc tablets along with adequate nutritional intake by the child during diarrhoea. Diarrhoea can be prevented with use of safe drinking water, hand-washing, sanitation, immunization and breastfeeding/appropriate nutrition.

What is IDCF? How is it implemented?

Intensified Diarrhoea Control Fortnight (IDCF) consists of a set of activities to be implemented in an intensified manner from 12th to 24th June 2018 for prevention and control of deaths due to dehydration from diarrhoea across the state. These activities mainly include- intensification of advocacy & awareness generation activities for diarrhoea management, strengthening service provision for diarrhoea case management, establishment of ORS-Zinc corners, prepositioning of ORS by ASHA in households with under-five children and awareness generation activities for hygiene and sanitation.

Objective and Strategy:

1. Goal of IDCF:

The goal of IDCF is 'to attain zero child deaths due to childhood diarrhoea.'

The overall objective of IDCF is to ensure high coverage of ORS and Zinc use rates in children with diarrhoea throughout the country along with inculcating appropriate behaviour in care givers for diarrhoea

prevention & management of under-five children, with emphasis on the high priority areas and vulnerable communities.

2. Specific objectives of IDCF:

- To improve usage of ORS and Zinc for childhood diarrhoea.
- ii) To complement awareness activities (including Swachh) for prevention and management of diarrhoea in under-five children.

3. Strategy for the IDCF:

The focus of IDCF is on delivery of simple proven interventions that have large impact towards control of childhood diarrhoeal morbidity and mortality. The IDCF strategy is three folds:

- i) Improved availability and use of ORS and Zinc in the community
- ii) Facility level strengthening to manage cases of dehydration
- iii) Enhanced advocacy and communication on prevention and control of diarrhoea through IEC campaign.

4. Overview of IDCF activities for 2018:

- i) At Community/Village Level
 - Distribution of ORS (and Zinc) and demonstration at the household level
 - Inter Personal Communication (IPC) activities by ANM/ ASHA on hygiene and sanitation along with management of diarrhoea.

- washing demonstration schools
- Mobile health teams for urban areas & hard to reach area.

ii) At Health Facility Level

- Establishment of ORS and Zinc corners for treatment of diarrhoea
- Promote standard case management of diarrhoeal cases
- Cleaning of water tanks in health facilities, provision of safe drinking water

iii) Convergence of allied departments

IDCF involves coming together of different departments like School Education (Hand washing demonstration and provision of safe drinking water), Social Welfare (ORS-Zinc corners in Anganwadi centers and nutrition support) and PHED/ PWD (Sanitation and safe drinking water). The civil administration also has a responsibility in bringing departments together. these Awareness generation needs the active involvement of church, the village health committees, NGOs and the media.
