Interested candidates from bonafide Indigenous Inhabitants of the State of Nagaland are hereby invited to undergo Training in General Nursing & Midwifery (GNM) and Female Health Worker (FHW) for the session 2022-2023 for the 4 (Four) Schools of Nursing in Nagaland as indicated below.

1. Minimum and maximum age for admission will be 17–25years on or before 31st Dec,2021.
2. Application Form duly filled up along with necessary documents duly self attested may be submitted along with the Schedule Tribe and Indigenous Inhabitant Certificate which is compulsory for all while submitting the form.
3. No separate calling letter will be issued.
4. **Issue of Application Form July 4th, 2022**
5. **Last Date of Submission of Form July 25th, 2022**
6. **Issue of Admit cards 30th & 31st August, 2022**
7. Course details-
 - A. **(GNM) (School of Nursing, NHAK, IMDH Mokokchung, D.H. Dimapur)**
 - i. For unmarried Male / Female candidates
 - ii. 3 (Three) years course, 100 (one hundred) seats.
*Kohima-20 seats, Mokokchung-40, Dimapur-40 seats
 - iii. Qualification –
 - (a) Class 12 passed in any stream with 45%.
 - (b) The ratio of Seats for science is 70% and other Streams is 30%
 - B. **(FHW) (School of Nursing, D.H. Tuensang)**
 - i. For unmarried Female candidates only.
 - ii. Two years course, 30 (Thirty) seats.
 - iii. Qualification:
Class 12 passed in any stream with 40% from recognized English medium School Board, 45% from Recognized National institute of Open School.
8. There will be written and viva test (Dates will be notified later)
9. For Central board institution whose results are awaited can apply by submitting their Class12 admit Card along with the requisite documents, after the results are declared they should submit a Xerox Copy of the Mark sheet to the Office.
10. Incomplete Application, if submitted will be rejected summarily. List of rejected application will be published in the Office Notice Board.

Backward Tribe Reservation Policy (15%) will be followed as per Govt. Notification No.HTE/RESEV/23-1/2012 Dated, Kohima, the 30th May, 2016.
