# CONSTITUTION OF SEARCH COMMITTEE FOR APPOINTMENT OF LOKAYUKTA

In pursuance of Section 3(2) of the Nagaland Lokayukta Act, 2017 and Section 3 Sub-Section 2 (ii) of the Nagaland Lokayukta (Amendment) Act 2019, Personnel & Administrative Reforms Department stated that a Search Committee has been constituted for identifying candidates to be considered for appointment as Lokayukta Nagaland with the following members:

- 1. Chief Secretary, Nagaland
- 2. Advocate General of Nagaland.

# LABOUR COMMISSIONER INFORMS

Labour Commissioner, Er. S. L. Wati Aier has informed that in line with recommendations of the 44<sup>th</sup>, 45<sup>th</sup> and 46<sup>th</sup> Session of Indian Labour Conference (ILC) and demands from various quarters, the Government of India has amended the Maternity Benefit Act 1961 by way of the Maternity Benefit (Amendment) Act 2017. Vide this amendment, one important provision was enabling provision for permitting work from home for nursing mothers. Section 5(5) of the Act provides as follows:

"(5) In case where the nature of work assigned to a woman is of such nature that she may work from home, the employer may allow her to do so after availing the maternity benefit for such period and on such conditions as the employer and the woman may mutually agree."

In the context of prevailing COVID-19 pandemic, nursing mothers are a highly vulnerable lot and the need to protect this segment of the population from getting infected by corona virus cannot be over emphasized. Allowing nursing mothers to work from home can contribute to protecting them and their babies from getting infected. It is in this scenario that the enabling provision for allowing 'work from home' assumes significance and hence needs to be popularized amongst the women workforce, and the employers are advised to allow more nursing mothers to work from home wherever nature of work allows to do so, at least for a period of one year from the date of birth of the child.

All employers of mines, plantations, shops and establishments (either in organized sector or unorganized sector) and factories are therefore, advised to comply with the above information.

# **NBSE INFORMS ON NATIONAL EDUCATION POLICY**

The National Education Policy (NEP) 2020 talks about the education system that lays emphasis on experiential learning with a focus on 21<sup>st</sup> century skills like critical thinking and problem solving. The NEP 2020 aims at developing a holistic and multi-disciplinary education and therefore, has stressed on the integration of vocational education with the general education so as to eliminate the hard separation between arts and sciences, between curricular and extra-curricular activities, and between vocational and academic streams. This policy aims to ensure that every child learns at least one vocation and is exposed to several more from Class VI onward. This would lead to emphasising the dignity of labour and importance of various vocations. It is the goal of the policy to reach out to at least 50% of the learners to have exposure to vocational education by 2025.

The vocational/skill education is within the ambit of National Skill Qualification Framework (NSQF) which organises qualifications according to a series of levels of knowledge, skills and aptitude. The

NSQF defines common principles and guidelines for nationally recognised qualification and certification encompassing schools, vocational institutes and institutes of higher education throughout the country. The qualification ranges from secondary to doctorate level leading to international recognition of national standards. The NSQF is a competency based skill framework that will provide for multiple pathways of vertical and horizontal mobility with multiple entries and exits both within vocational education, vocational training, general education and technical education, thus linking one level of learning to another higher level. This will enable a person to acquire desired competency levels, transit to job market and, at an opportune time, return for acquiring additional skills to further upgrade their competencies.

In pursuant to the goal of NEP 2020, to reach out to 50% of the learners, the Nagaland Board of School Education is introducing Vocational Education from Classes IX to XII from 2022 academic session in a phased manner, i.e. to begin with Class IX. The vocational education will be an optional subject in classes IX and X and an elective subject in classes XI and XII.

The Competency Based Curriculum and Syllabus for Vocational Education for classes IX-XII has been adopted from the curriculum and syllabus developed by the Pandit Sunderlal Sharma Central Institute of Vocational Education (PSSCIVE), Bhopal.

In this regard, the registered schools have been encouraged to come forward in introducing vocational education in their schools to nurture the skill requirements of the learners. The application form for the introduction of the vocational education is uploaded in the portal, www.nbsenl.edu.in in the forms section. All necessary instructions are appended in the form itself. The following is the list of the courses for introduction:

The sign language interpretation has been incorporated in the video broadcast for the benefit of children with disabilities and broadcast of lessons for students of Classes VII to X will commence shortly.

Further, all concerned shall ensure that the directives issued vide this Office Notification of even number, dated 12<sup>th</sup> July 2021 with regard to the arrangements to be made for facilitating learning through the online mode of education are complied with.

# **GOVERNMENT NOTIFIES IN CHANGE OF NOMENCLATURE**

State Government in a notification rectified the nomenclature "Yimchunger" Naga to "Yimkhiung" Naga. It stated that the name "Yimkhiung" shall be used in all official correspondence.

The order has been issued with the approval of the Cabinet in its meeting held on the 31<sup>st</sup> July 2021 conveyed vide letter No. CAB-2/2013 dated 31/07/2021.

# STATE GOVERNMENT GRANTS REMISSION

On account of celebration of the 75<sup>th</sup> Independence Day on 15<sup>th</sup> August 2021 and consequent to the proposal submitted by DG (Prisons), Home Department has informed that the Governor of Nagaland has granted remission to the following eligible convicted prisoners as: Central Jail, Dimapur – 15, District Jail, Dimapur – 6, District Jail, Kohima – Nil, District Jail, Mokokchung – 7, District Jail, Wokha – Nil, District Jail, Tuensang – 4, District Jail, Peren – Nil, District Jail, Mon – 12, District Jail, Phek – Nil, District Jail, Kiphire – Nil, and District Jail, Zunheboto – 2.

The Remission Order will take effect from the 15<sup>th</sup> of August 2021 by Order and in the name of the Governor.

# **STATE GOVERNMENT INFORMS**

In commemoration of the ensuing 75<sup>th</sup> Anniversary of Independence Day, 2021, the State Government has decided to remit the sentences for certain categories of prisoners who have been convicted by the courts (other than Court Martial) having criminal jurisdiction in the State of Nagaland and sentenced to rigorous imprisonment.

In exercise of the power conferred by Sub-Section 1 of Section 432 of the Code Criminal Procedure, 1973 (Act No. 2 of 1974 herein after referred as the said Code), the State Government has granted remission of sentences to the different categories of prisoners as specified below, lodged in the jails of Nagaland and outside, other than those in respect of whom the sentence is inflicted for an offence against the Order referred to in Sub-Section 6 of Section 432 of the said Code passed under any law relating to which the Executive Powers of the Union extends.

The scale of remission of sentence for different categories is specified below:

## CATEGORY SCALE OF REMISSION

- Prisoners sentenced to 10 years and above
   Prisoners sentenced to 5 years to 10 years
   Prisoners sentenced to 1 year to 5 years
   20 (Twenty) days
   10 (Ten) days
- 4. Prisoners sentenced up to 1 year 5 (Five) days

Further, the aforesaid remission granted under the Order shall not be admissible to the following categories of prisoners:

- 1. Prisoners convicted under Foreigners Act
- 2. Prisoners convicted under Passport Act
- 3. Prisoners convicted under Unlawful Activities (Prevention) Act
- 4. Prisoners convicted under Section 3 to 10 of Official Secrets Act 1923.
- 5. Prisoners convicted under Section 2 to 3 of Criminal Amendment Act 1961
- 6. Prisoners convicted under Section 121 to 130 of IPC
- 7. Prisoners convicted under Section 107/109 of CrPC
- 8. Prisoners convicted under Prevention of Corruption Act
- 9. Prisoners convicted of rape, attempt to rape or assault on women
- 10. Convicted prisoners found violating jail rules and discipline such as threatening/intimidation/quarrelling/beating of fellow prisoners/staff and smuggling of contraband and prohibited articles
- 11. Foreign National convicted under any Acts.

  The Remission Order will take effect from the 15<sup>th</sup> August 2021 by Order and in the name of the Governor.

# TRANSPORT DEPARTMENT INFORMS ON ISSUE OF PERMITS

Transport Department has informed that in supersession of notification of even no. dated 6<sup>th</sup> May 2021, the State Transport Department has laid down the following guidelines on issue of Permits for all Goods Transport Vehicles and Passengers Service Vehicles in the State which shall come into immediate effect.

Under Section 73(a)(ii) and (iv) of the Motor Vehicles Rules for Excluded Areas, Assam, 1942 Nagaland Amendment Rules, 1983) as amended vide Notification No. TPT/MV/2/79 dated 30/03/1983, Para 16, the fees for permits in respect of Goods Transport Vehicles and Passenger Service Vehicles are fixed as under:

- 1. In respect of Transport Vehicles, Rs. 25 per m.t per year.
- 2. In respect of a Taxi cab/Tourist Taxi, Rs. 200 per year.
- 3. In respect of a Stage carriage/City bus/Omni Bus, Rs. 320 per year.

Under the provisions of Section 69(2) of the Motor Vehicles Act 1988 and Rule 86 of Central Motor Vehicles Rules 1989, the State Transport Authority has issued the base permits and national permits for all Goods Transport Vehicles.

Further, under Rules 82(1) of the Central Motor Vehicles Rules 1989, the State Transport Authority is authorized to issue base permits for all categories of Passenger Service Vehicles for the purpose of availing permits for Tourist Vehicles on the basis of which the All India Tourist Permit Authorization, Inter-State Permits, All Nagaland Tourist Taxi Permits, Inter-District Contract Carriage (Bus) Permits shall be issued, provided that the applicant must first obtain an assurance certificate from the State Transport Authority for issue of the above permits.

# **NBSE NOTIFIES**

The Nagaland Board of School Education (NBSE) has notified for information of all concerned that the NBSE is a Member Board of the Council of Boards of School Education in India (COBSE). The NBSE grants reciprocal recognition to the certificates of examinations conducted by the Member Boards/Councils of COBSE only.

The NBSE admits only the students who have studied from the Member Boards/Councils of COBSE and on fulfilment of the criteria prescribed by the Board. As such, all registered institutions shall admit only those students who have been certified passed or qualified at an examination by Member Board or Council of COBSE.

Before admitting, the institution shall also verify and check that the student have studied and appeared in the Core subjects i.e. Mathematics, Science, Social Sciences, English and a Second language.

# **NBSE NOTIFIES ON PLANNED ACTIVITIES**

# MINUTES OF THE MEETING HELD BETWEEN THE CHIEF SECRETARIES OF NAGALAND AND ASSAM

A meeting was held on 31<sup>st</sup> July 2021 between the Chief Secretary of Nagaland and Chief Secretary of Assam at Dimapur, Nagaland with a view to de-escalate the tense situation prevailing in 2(two) locations in the Dessoi Valley Reserved Forest/Tsurangkong Valley due to stand-off between the armed police forces of Nagaland and Assam.

Both sides agreed that in order to maintain peace and tranquility in the areas around Ao Senden village and Vikuto village as they are known in Nagaland, and known as Jankhona Nala/Nagajankha (26°36'52.9"N 94°22'27.3/"E) and Compartment No. 12(26°34'33.7"N 94"19'05.9"E) respectively in Assam, urgent and effective steps are required for defusing the stand-

off between the security forces of Nagaland and Assam.

In this regard, it is decided by both sides that the security personnel of both states shall simultaneously move back from their present locations to their respective base camps. The simultaneous withdrawal of the security personnel shall begin immediately.

Nagaland and Assam shall monitor the area by surveillance using UAV and satellite imagery with a view to maintain the status quo. The Superintendents of Police of the districts of Mokokchung (Nagaland) and Jorhat (Assam) shall ensure orderly withdrawal of their respective forces and shall be responsible for it in the instant case.

# 2<sup>nd</sup> EDITION OF NAGALAND REGIONAL EASTERN HIMALAYAN NATURENOMICS™ FORUM HELD



Nagaland Regional Eastern Himalayan Naturenomics™ Forum 2021 was held on 1<sup>st</sup> August 2021 at Sukhai village of Zunheboto district, bringing together community voices, government officials, SHG groups, farmers and indigenous organizations towards understanding community conservation model in Sukhai, and exploring opportunities for a sustainable future. The theme of the forum was 'Understanding the socio-economic conservation models for biodiversity preservation in Community Conserved Areas (CCA).' The Nagaland Regional Eastern Himalayan Naturenomics™ Forum has been hosted, partnering with the Tizu Valley Biodiversity Conservation and Livelihood Network

(TVBCLN) and The Energy and Resources Institute of India (TERI).

Due to the COVID-19 pandemic, Balipara Foundation conducted the regional colloquium adhering to SOP and norms regulated by Nagaland State Government, registered by a total of 35 participants, including resource persons, community representatives and volunteers.

Sukhai has brought into light the rich biodiversity the village has, and how every effort has been taken towards mobilizing the community members towards preserving the land. Chairman of Sukhai CCA and leader of TVBCLN, Ivan Jimo highlighted upon the indigenous culture and

tradition of Sema Naga communities which are interlinked to nature since time immemorial.

The discussion was carried forward by a presentation on "Biodiversity vis-a-vis Shifting Cultivation to Nagaland" by Pikato V. Jimo, the POU of Nagaland Empowerment through People Economic Development (NEPED) and the General Secretary to Sukhai CCA. Talking about the traditional farming practices once practiced in the CCA across Sukhai and nearby villages, Jimo stated that conservation won't be successful, until we provide livelihood options. He further went on to say that shifting cultivation does not always degrade the ecology, and it is a far more economically and biologically sustainable way of farming when compared to settled form of agriculture.

Talking on the Article 371A, and land ownership in Nagaland, Chief Conservator of Forests (Environment, Biodiversity & Research), Nagaland, Supongnukshi IFS stated that forest and ecosystem management in the State involves many stakeholders like Forest Department, Agriculture Department and civil societies, amongst others. "As per Forest Survey of India Report 2019, over 75.31 % of total geographical area of Nagaland is under forest cover. Open Forest Category of forest lands largely fall under the jhum fallow lands," he informed.

The event designed to witness insightful deliberations in context to indigenous people, forest management and traditional practices witnessed informative deliberations and presentations from an eminent panel of other speakers like Dr. Rakesh

Kumar Chaursia, Head & Senior Scientist to Krishi Vigyan Kendra (KVK) Nagaland, Heirang Lungalang, Chairman to the Nagaland Community Conservation Areas Forum (NCCAF) and Rokongulie Meyase, professional bird guide and tour operator from Khonoma CCA.

Formulating the Regional Nagaland Chapter, Balipara Foundation in coming days envisions to work closely with the indigenous communities of Nagaland through its flagship project Rural Futures and Naturenomics™, to ensure a sustainable future for the State and celebrate the indigenous conservationists as the custodians of the natural landscapes - protecting and preserving their lands.

The forum was organized by Balipara Foundation, a non-profit organization nestled in Assam in the Eastern Himalayas. Established in 2007, Balipara Foundation focuses on community development and conservation of natural resources in the region through the concepts of Naturenomics™ and Rural Futures.

# 8th SESSION OF THE THIRTEENTH NLA

#### **OBITUARY REFERENCES:**

The 8<sup>th</sup> Session of the Thirteenth Nagaland Legislative Assembly (NLA) began on 3<sup>rd</sup> August 2021, with the Chief Minister, Nagaland, Neiphiu Rio making Obituary References to the passing away of sitting Member of NLA, Toshi Wungtung. Late Toshi Wungtung who served as Advisor, Information & Public Relations, SCERT and Village Guards, passed away on 1<sup>st</sup> July 2021 after a brief illness at BLK Hospital, New Delhi. Rio mentioned that Late

Toshi Wungtung, besides being a promising leader and an active MLA, was also an intellectual, working with various organizations, civil societies and NGOs. He stood for the masses, a knowledgeable and outspoken advocate who stood for the preservation of Naga culture and identity. Rio stated that his legacy will continue to live on throughout the many lives of the younger generation, and on behalf of the House, he conveyed heartfelt condolences to the bereaved family and prayed that God will

continue to give them strength and courage to overcome the difficult times.

Speaker, Nagaland, Sharingain Longkumer also made Obituary References to the following former Members of NLA:

### STARRED QUESTIONS:

Replying to starred question raised by MLA, Kuzholuzo Nienu, Chief Minister Neiphiu Rio who is the Minister in-charge of CAWD, replied that 93% of the works of the DC Complex in Phek is completed. The total project cost revised is Rs. 972.46 lakh, the total amount allocated for the work upto date is Rs. 555.65 lakh, payment made upto date is Rs. 557.41 lakh and the balance amount yet to be paid is Rs. 316.81 lakh.

With regard to the starred question raised by MLA, Dr. Chotisuh Sazo about the details of Medical Centres in Chozuba, Minister, Health & Family Welfare, Pangnyu Phom replied that there are 37 posts sanctioned against CHC Chozuba including two posts of Medical Officer, and all the posts, except one post each of Staff Nurse and Sweeper are filled up. He added that officers/staff have not been appointed against Trauma Centre, Chozuba since no separate posts were approved for appointment under the scheme for establishment of the same.

Replying to starred questions raised by MLA, Y. M. Yollow, on the second day of the 8<sup>th</sup> Session of the Thirteenth NLA on 5<sup>th</sup> August 2021, Minister for PHED, Jacob Zhimomi informed that the Wakching water supply project was sanctioned during the year 2014-15 with an estimated cost of Rs. 383.01 lakh. He added that the project is

expected to be completed by March 2022.

Minister for Health & Family Welfare, S. Pangnyu Phom informed that the Government has sanctioned Rs. 246.9 crore for COVID-19 related expenses since 2019-20, wherein, an amount of Rs. 127.33 crore was received by Department of Health & Family Welfare and the remaining Rs. 199.57 crore was for expenditure by Home Department/ NSDMA. This was in reply to the questions raised by MLA. Kuzholuzo Nienu.

Deputy Chief Minister, Y. Patton replying to MLA, Yitachu's starred question stated that an amount of Rs. 304.19 lakh has been released so far for the work pertaining to Weziho-Molen road construction with 40% of the overall works completed.

Replying to MLA, Y. M. Yollow, Minister for Higher Education stated that the Department will be in a position to start the first academic session at New Model College, Wakching only after the State Government sanctions approval for creation of the proposed minimum required post for appointment.

Answering to the question on the status of Kohima By-Pass Package-2 of Meriema, 500 meters tunnel raised by MLA, Kuzholuzo Nienu, Deputy Chief Minister and Minister in-charge of Roads &Bridges, Y. Patton stated that 55(fifty five) meters tunnel excavation works from western portal side has been completed so far.

On Akash Bridge to Kanjang via Lephory road construction, Patton informed the House that a fund amounting to Rs. 1018.42 lakh has been released and the expected date of completion is 31/03/2022. This was in reply to a starred question raised by MLA, Yitachu.

Replying to question raised by MLA, Y. M. Yollow, Minister in-charge of School Education said that the Government Primary School at Ladigarh was established in 1972 and the school is presently located on the outskirts of Ladigarh village.

Dr. Chotisuh Sazo, MLA raised questions on COVID-19 vaccination to which Minister of Health & Family Welfare, S. Pangnyu Phom said that vaccination is not mandatory in Nagaland and is voluntary. It is disseminated to the public and target

beneficiaries, as part of mobilization/outreach and sensitization activities.

### **UNSTARRED QUESTIONS:**

While replying to the unstarred question raised by MLA, Kuzholuzo Nienu on 5<sup>th</sup> August 2021, Deputy Chief Minister and Minister in-charge of Roads & Bridges, Y. Patton, informed that there are 5,167 work charge labourers in the State, PWD (NH) -130, PWD (R&B) –4031, PWD (Housing) – 1,006.

Chief Minister, Neiphiu Rio replying to MLA, Keneizhakho Nakhro, informed that the strength of staff of Task Force for Music & Arts is 8 (Eight): Project Director- 1 (Deputation), Sound & Light Engineer- 1 (Contract), Manager (Electronics & Power)- 1(Contract), Handyman-cum-Peon - 1 (Regular), Sweeper-cum-Chowkidar- 1(Regular) and Contingency-3.

MLA, Y. M. Yollow raised unstarred questions on the Assam-Nagaland border and Ladigarh polling station, to which the Minister incharge of Border Affairs informed that the Assam-Nagaland border issue is sub-judice in the Supreme Court of India and the State of Nagaland is defending the suit in all possible manners. Further, whenever the situation so warrants, meetings are held between Assam and Nagaland counterparts at various levels. The Minister in-charge informed that the Assam-Nagaland inter-state border are as follows: Mon - 63 Km, Longleng - 9 Km, Mokokchung - 100 Km, Wokha - 117 Km, Kohima - 3 Km, Dimapur - 125 Km and Peren - 96 Km approx. He stated that post 1972 Agreement, Doyang and Kakadanga Reserve Forest under Wokha district has the largest area encroached by Assam. Further, he informed that in the elections conducted, the electors of the Ladigarh polling station under 49 A/C Tamlu, are voting at a nearby makeshift camp approximately 1 Km away from the school between Ladigarh and Yonglok village as per the directives of the Election Commission of India. He said that Ladigarh village is shown under Assam territory in the map in the website as per the Survey of India map that follows the 1925 boundary line, which is disputed by the State Government.

# PRESENTATION OF ASSEMBLY COMMITTEE REPORTS:

On the second day of the 8<sup>th</sup> Session of the Thirteenth NLA, on 5<sup>th</sup> August 2021, Advisor, School Education and Chairman of the Public Accounts Committee, K. Tokugha Sukhalu presented before the House the 125<sup>th</sup> Report of the Committee on Public Accounts (2021-2022) on the examination of the Report of the Comptroller & Auditor General of India for the year 2016-2017 on the State Finances Audit Report and Audit Reports on the Social, Economic, Revenue, and the General sectors.

Member and Chairman of the Committee on Subordinate Legislation, Dr. Chotisuh Sazo laid the following Reports:

 The Sixty-Sixth Report on the Nagaland Shops and Establishment Rules, 2015.



- ii. The Sixty-Seventh Report on the action taken by the Government on the 55<sup>th</sup> Report on the Nagaland Labour Service Rules, 2014.

Member and Chairman of the Committee on Government Assurances, Y. Vikheho Swu presented the following Reports before the House:

Chief Minister, Neiphiu Rio presented before the House the Report of the Comptroller & Auditor General of India on General, Economic and Revenue Sectors for the year ending 31<sup>st</sup> March 2019.

CONSIDERATION AND PASSING OF GOVERNMENT BILLS: Chief Minister, Neiphiu Rio moved the 'Nagaland Professions, Trades, Callings and Employment Taxation (Fifth Amendment) Bill, 2020' and 'The Nagaland Lokayukta (Amendment) No. 2 Bill, 2021' for consideration, and both the bills were passed by the House.

#### **DISCUSSION ON NAGA POLITICAL ISSUE:**

Minister, Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu initiating the discussion gave a timeline of constitution of the Parliamentary Committee for the Naga Political Issue. On 16<sup>th</sup> July 2021, a

Parliamentary Committee (Joint Legislators Forum nomenclature changed), was constituted comprising of all 60 elected Members of Nagaland Legislative Assembly (NLA) and both the Members of Parliament. A Core Committee within the Parliamentary Committee comprising of 22 members was set up to discuss the issue in more detail. The first Core Committee meeting was held on 9th July 2021 where a 5-Point Resolution was adopted, after which a meeting was held with the 7 NNPGs on 20th July 2021 and with NSCN-IM on 21st July 2021. Kronu stating that if the Naga Political Issue is not resolved, it will hamper the entire system and society, and with the GoI and negotiating parties having reached this far, he said time is crucial now and called for more efforts and suggested for the House to make a resolution and approach the negotiating parties.

Minister, Kashiho Sangtam suggested for the Parliamentary Committee or the Core Committee to negotiate with Naga representatives, NSCN-IM and 7 NNPGs, and appealed to them to leave past and present differences and come together for the Naga people. Advisor Khehovi Yepthomi said that when the Gol is showing seriousness in solving the issue, we should not miss the opportunity as the more we delay and neglect talks, more political groups will crop up. MLA, Imkong L. Imchen called for all the negotiating parties not to have rigid stance and said that in modern and contemporary politics, it cannot always be winner takes all, there has to be shared victory. MLA, Chotisuh Sazo called for the negotiating parties to be transparent with the agreed position. MLA, Y. M. Yollow Konyak stated that the 60 elected Members of the NLA and two MPs have the mandate of the public, and he appealed to all negotiating parties to come together for the Nagas.

MLA, Kuzholuzo Nienu stated that from day one, Nagas' demand was for sovereignty, therefore any solution or settlement that comes about cannot be taken as a final settlement. Advisor, Pukhayi expressed that the Naga Political Issue should come into solution, as Nagas have every right to

have freedom. He pointed that the House passing a resolution should not contradict to any group but the voice of the August House should conclude in a peaceful settlement. Suggesting some prepositions on the Naga Political Issue, MLA, Dr. Chumben Murry said that the Core Committee, on behalf of the Parliamentary Committee should urge the leaders at the Centre to be magnanimous on the issue of the Naga Flag, and at the same time, have more discussions with the NSCN-IM group and urge them to reconsider their stand on the line of the 31st October Agreement, in the interest of the Nagas.

Minister, Tongpang Ozukum while appreciating the supreme sacrifices made by the Naga Political Groups since the beginning of the movement, also appealed to them to forget and forgive the past mistakes and to come together as one. MLA, Yitachu said that the main reason to form an oppositionless Government is an effort on history making of the Nagas, to arrive at an early and peaceful solution. MLA, H. Chuba Chang said that Naga issue can be solved only politically and called all the leaders to unite in finding a lasting solution which is agreeable to everyone. Advisor, Dr. Longrineken asked the August House to pass a resolution and make an appeal to the two groups NSCN-(IM) and NPPG to negotiate with the Gol as united Naga and coin the differences and sacrifices for our future generation, to put aside the political issue and endorse for the interest of the Naga.

Leader of Opposition, T. R. Zeliang recalled that the NPF walked out on Naga Political Issue in 2020 due to the fact that the JLF was not making

much positive progress, and subsequently, proposed that a Parliamentary Committee should be constituted with all the elected representatives and the two Members of Parliament, to which he thanked the Leader of the House for accepting the proposal. It was felt that both the parties (NDPP and NPF) need to leave aside their political differences, to help facilitate the Naga Political Issue and to fulfil the aspirations to the Naga people. He appealed to the negotiating parties, the Government of India and Naga Negotiating Groups to stick to what has been agreed upon on 31st October 2019, as claimed by both the negotiating parities that the talk has completed successfully.

Leader of the House, Chief Minister, Neiphiu Rio stating that though the Naga society is divided on many things, the elected members of NLA since 1964 have unanimously passed all the 12 resolutions on the Naga Political Issue. He stated that during the Core Committee meeting with the NNPG group and NSCN-IM, all parties have conveyed their concern on finding a solution. Highlighting the uniqueness of the Naga Political Issue, he said that after Article 370 was removed, even Jammu and Kashmir has demanded for Article 371(A) like Nagaland.

### RESOLUTION ON THE NAGA POLITICAL ISSUE:

- The House appeals to the negotiating parties
  of the Indo-Naga political dialogue to resume
  the peace talks with a positive approach and
  mutual respect for each other by setting aside
  pre-conditions, in deference to the Naga
  people's cry for long term peace, and resolve
  the contentious issues of the competencies at
  the earliest.
- 2. The House appeals to all Naga Political Groups to make serious efforts towards unity and reconciliation. The constant antagonism against each other, especially in public space and the media is sending out a wrong message to the masses, considering the fact that we are all pursuing the same aspiration of peace and political solution. Taking the positive example set by the elected Members of the Nagaland

Legislative Assembly, who have risen above party affiliations to unite for the Naga Political Issue, the Naga Political Groups should make concerted efforts, and listen to the voice of the people for unity and oneness.

- 3. The House, while appreciating the constant role and contributions of the churches, civil societies and the NGOs towards facilitating peace and strengthening the peace process, appeals to the civil societies, mass-based organisations and the Tribal Hohos to make renewed efforts towards creating a conducive atmosphere for the early realisation of a political solution by pursuing unity, reconciliation and oneness.
- 4. All Members of this House have come together under the same banner in line with the election manifestos of all political parties committing ourselves to the people that all the elected Members are prepared to make any sacrifices for an inclusive, honourable and acceptable solution.
- The House, therefore, appeals to the Naga Political Negotiating Groups to come together in order to hammer out their differences, and give the people 'One Solution and One Agreement.'

# DISCUSSION ON NAGALAND-ASSAM BORDER ISSUE:

Taking part in the discussion on matters of urgent public importance on 'Nagaland-Assam border,' MLA, Imkong Imchen stated that Assam Government has border disputes with various North Eastern states and mentioned that the recent clash between the Government of Assam and Mizoram Government is a classic example of the aggressive policy of Assam Government. He suggested to the Chief Minister of Nagaland to coordinate with all the Chief Ministers of the North Eastern states to have a common platform and pursue the matter to the Prime Minister of India to intervene with the aggressive policy of the Assam Government. Imchen also suggested to the Leader of the House to constitute a cabinet Sub-Committee on border

management to deal and review all the agreement entered with the Assam Government. He added that Nagaland Armed Police Force should be deployed to avert any aggressive policy and protect the border area of Nagaland. He urged the Government to expedite the compilation of the Foot Hill Road at the earliest to avoid issues arising due to bandh imposed in Assam.

MLA, Yollow Konyak suggested that the Government can have a proper land holding system in order to protect the interest of the people living in the border area and emphasized on the need for proper deployment of the State police force to tackle law and order problem.

Advisor, Horticulture and Border Affairs, Mhathung Yanthan briefed the House on the history and events of the State since the creation of the Naga Hills district under Assam in 1866. Lamenting the usage of satellite imaginary in disputed areas, he called for solving the issue by visiting the disputed areas and getting firsthand knowledge. Terming the border issue with Assam a 'perpetual problem,' he sought for concerted effort in solving the problem.

Minister, Higher Education and Tribal Affairs, Temjen Imna Along said that the Nagaland-Assam border issue has remained unsettled ever since Nagaland became the 16<sup>th</sup> State of India. Under this issue, he suggested to the House to upgrade the Border Magistrate to a DC level. He requested that the 13 IRB be sent to the recent disputed areas in order to avoid any future unfortunate incidents. He also said that border outposts should be strengthened with more assertiveness.

MLA, Moatoshi Longkumer raised various problems faced by the Nagas due to land disputes with Assam. He stated that the issue has been hampering developmental and farming activities and urged for deployment of neutral security forces like CRPF at the disputed areas.

Discussing on the Assam-Nagaland boundary issue, Leader of Opposition, T. R. Zeliang stated that the boundary dispute has created unrest for people of both the states. He said that despite

such conflict and turmoil, even the Supreme Court has not been able to finalise the boundary issue which he felt was due to the complexity of the matter. Giving a brief historical background of Nagaland, Zeliang stated that there have been Agreements between Assam and Nagaland to solve boundary disputes but the problem continue to exist which he believes, is partly due to the fact that some clauses in the Agreements signed between the two Governments are biased and thereby, unreliable and have worked to the disadvantage of Nagaland to a large extent. He also suggested that a Parliamentary Panel be constituted to study the border dispute issue and to submit its report within a stipulated time period.

Chief Minister, Rio said that he fully endorses with the Leader of Opposition regarding the Nagaland-Assam issue. He also said that the people of Nagaland should unite and take a common stand on this issue stating that the agreement between the two states should be without any preconditions.

# RESOLUTION ADOPTED BY NAGALAND LEGISLATIVE ASSEMBLY ON ASSAMNAGALAND BORDER ISSUE ON 5th AUGUST 2021:

The House unanimously adopted Three Point Resolution adopted by Nagaland Legislative Assembly on Assam-Nagaland Border Issue on 5<sup>th</sup> August 2021 and decided to pass the following resolutions:

- A Select Committee of the House be constituted to examine all aspects of the Assam- Nagaland border issue and submit its report within a period of 3 (three) months. The Select Committee shall consist of the following Members:
  - i. Neiphiu Rio, Chief Minister
    - Convenor
  - ii. Y. Patton, Deputy Chief Minister
    - Co-Convenor
  - iii. T. R. Zeliang, Leader of Opposition
    - Co-Convenor
  - iv. P. Paiwang Konyak Member

- . Jacob Zhimomi Member
- vi. Mhathung Yanthan Member
- vii. Amenba Yaden Member
- viii. K. G. Kenye, Member of Parliament, Rajya Sabha - Special Invitee
- ix. Tokheho Yepthomi, Member of Parliament, Lok Sabha - Special Invitee
- x. Commissioner, Nagaland and Secretary i/c of Border Affairs Secretary
- 2. Request the Union Home Minister to ensure maintenance of status quo in letter and in spirit in the disputed area till settlement of the issues.
- 3. The border issue should be amicably settled outside the court by the two State Governments, by involving the local communities from both sides.

# PANGNYU PHOM HIGHLIGHTS ON COVID-19 PANDEMIC SCENARIO IN THE STATE:

Minister of Health & Family Welfare, S. Pangnyu Phom made a statement under Rule 55 pertaining to COVID-19 pandemic during the 8<sup>th</sup> Session of the Thirteenth Nagaland Legislative Assembly on 5<sup>th</sup> August 2021.

Phom stated that the first wave required urgent measures in the form of imposition of lockdown to curtail the spread of virus and take steps to strengthen our healthcare system. The Government had taken steps by strengthening our testing facilities, creating posts and recruiting healthcare professionals in an expeditious manner. He said that requisite infrastructure, critical care equipments and ambulances were also provided to the District Hospitals and a State Warehouse was set up at Kohima to modernize the supply chain management, supported by a robust IT platform.

Stating that the second wave of COVID-19 has been much more severe than the first wave, Phom said that the State had more than 15,600 cases at a positivity rate of 11.5% in the four-month period comprising the second wave as compared to the 11,927 cases at a positivity rate of 9.7% for the nearly one-year period of the first wave.

To augment the human resources,



Pangnyu informed that 390 posts were created in 2020 specifically keeping in view the requirements on account of COVID and around 150 resultant vacancy posts were also filled up in an expeditious manner. 150 Medical Officers, 14 Specialists, 258 Nurses, 5 Dental Surgeons, 23 AYUSH MOs, 6 Research Scientists and 6 BSL Lab Technicians, 54 ANMs/FHWs, 11 OT technicians and 10 ECG technicians were appointed to meet the requirement of healthcare professionals for COVID-19 and incentives were also announced for private doctors, he added.

The Minister mentioned that to meet the need for immediate augmentation of beds, private hospitals were also mandated for management of COVID-19 patients. Available resources were shared with the private hospitals and their capacities also enhanced. He said that to meet the increased hospitalization, bed strength was ramped up, which was 805 with 608 Beds without oxygen support, 68 Beds with oxygen support, 68 ICU beds without ventilators and 61 ICU beds with ventilators before the second wave to 1153 beds with 296 beds without oxygen support, 669 Beds with oxygen support, 99 ICU beds without ventilators and 89 ICU beds with ventilators respectively. He informed that a 200 bedded hospital is being built, with 24 paediatric beds, for acute medical care in CIHSR Dimapur which is likely to get operational by September, adding that the hospital will be immensely useful, should there be a third wave of COVID-19 pandemic.

Phom stated that the Department procured oxygen cylinders on a war footing and has nearly 6,000 cylinders of various capacities as compared to 1,417 cylinders at the beginning of the pandemic the previous year with the total capacity of oxygen that can be stored in the cylinders amounting to more than 17.5 Metric Ton. He mentioned that PSA Oxygen Generation Plants along with oxygen piping and generator backup have been installed at Kohima, Dimapur, Mokokchung, Tuensang and Phek to ensure availability of bedside oxygen and these plants have a daily capacity of 3.7 Metric Ton. He added that PSA Plants have been procured and

are under installation for other districts also. More than 2,000 concentrators have been procured or received through various sources oxygen concentrators and have been deployed at various medical facilities and have strengthened the oxygen supply chain, putting in place a State Depot in Dimapur and a Zonal Depot at Mokokchung. Resultantly, despite the sudden surge in cases, no patient had to suffer on account of lack of availability of oxygen or hospital beds, he added.

The Minister informed that out of 688 ventilators, 239 have been distributed to various health facilities including private hospitals. Besides the 3 BSL laboratories, he said that 25 TrueNat and 362 Rapid Antigen Testing facilities for COVID-19 have been established across the State and a total of 2,63,703 tests have been made since May 2020 to 31st July 2021,.

Stressing on the importance of COVID vaccination, Phom stated that the Government has launched mass COVID Vaccination drives and informed that a total of 7,67,535 doses of COVID-19 vaccines have been administered as of 30<sup>th</sup> July 2021 covering about 49.3% for the target of 1<sup>st</sup> dose and 12% for the target of 2<sup>nd</sup> dose.

Calling upon the House to be prepared for the third wave, Pangnyu Phom informed that a Paediatric Task Force has been set up under a senior Director of the H&FW with experts drawn from the private and public sector to look into our preparedness.

The Minister appreciated all the efforts being put in by all concerned and thanked the healthcare workers and frontline workers, both in the private and government sectors, who have put in their best efforts, performing their duties for long working hours and under stressful conditions. He added that everyone should continue to work together to ensure in addressing the challenges of COVID pandemic in the State.

# MATTERS ON URGENT PUBLIC IMPORTANCE ON POST COVID ECONOMY RECOVERY:

Minister for Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu,

said the COVID-19 pandemic has a huge impact on economic generation, so one of the topmost priorities of the present day Government is to retrieve back the economic generation with hard labour and by supporting the people. Kronu urged all the members for suggestions which can be helpful in bringing back the lost economy.

Minister for Agriculture, G. Kaito Aye informed the House that 70 percent of the population of the State is dependent on agriculture. He stated that the State has a huge set back on Agri and Allied sector due to shortage of rainfall and for which the Agri and Allied sector departments have set up a Core Committee in order to tackle the issue on the rainfall shortage and post COVID-19 impact. Ave added that the Department has planned various activities under Agri and Allied sector department which will be taken up in cluster approach wherein, fisheries, piggery, duckery, poultry, etc. along with terrace paddy cultivation, intercropping with various crops, vegetables and fruits etc. to ensure productivity. Sema also stressed that the Integrated Settled Farming at Boke Botsa would serve as a model and will be replicated in all the districts eventually. The Minister further stated that GPS mapping of the area will be taken by the GIS Cell and for which the Agri & Allied departments will have to prepare action plan for early implementation of Naga Model Integrated Settle Farming like the Boke Botsa

integrated farming project.

Advisor, Industries & Commerce, Imnatiba said that the outbreak of Corona Virus has significantly disrupted the global economy and our State is no exception to it. The Skill Development Department had initiated a job mela which attracted about 100 jobs in a single day. Unfortunately, the pandemic had forced the youths that were employed outside to come back to the State. He appealed to the Government to come up with a proper policy which would help give a face lift to the already struggling entrepreneurs in the State.

Chief Minister, Neiphiu Rio delivering his concluding remark said that the COVID-19 pandemic has been highly disruptive and challenging, and has impacted us in many ways but we have to look beyond the COVID-19 pandemic, to a future with high rates of sustained economic growth and better income levels for our citizens. He also said that lockdowns and restrictions have led to a sharp impact on economic activities at the global and national level and the State has also not been spared. He remarked that Agriculture and Allied activities continue to be the main source of livelihood for the rural people of Nagaland as this sector contributes more than 70% to the State's economy. Rio stated that travel and hospitality industry has been badly bruised by the pandemic but hopefully, we shall be having the Hornbill festival

# AGRICULTURE DEPARTMENT OFFICIALS VISIT KIKRUMA



# **UPDATED METEOROLOGICAL DATA OF NAGALAND 2019-2020 RELEASED**



An updated version of Meteorological Data of Nagaland 2019-2020, published by the Soil Survey & Land Use Planning Wing was released by Director, Soil & Water Conservation Department, K. Zhekheto Awomi, during a short programme conducted at his chamber.

Documentation of meteorological data is necessitated by growing importance of Applied Eteorology in Agriculture which is being witnessed in the wake of global climate change. The Department

currently has 17 Meteorological Stations spread all over Nagaland, the first being installed in 1981, which records weather parameters on a daily basis. Besides supplying the data to a host of offices every day, it is also availed regularly by many users such as researchers from all over India - Scientists, Engineers, Land and Water User departments etc. for various project formulations, construction activities, preparation of action plans, assessing of loss/damage due to natural disaster/calamities etc.

# CHIEF SECRETARY CHAIRS 3<sup>rd</sup> STATE LEVEL STEERING COMMITTEE MEETING ON NAFCC

The 3<sup>rd</sup> State Level Steering Committee Meeting on National Adaptation Fund for Climate Change (NAFCC) was held under the chairmanship of Chief Secretary, Nagaland, J Alam, IAS on 12<sup>th</sup> August 2021 at the Secretariat Conference Hall,

Kohima.

A brief presentation on implementation of NAFCC project in Nagaland was carried out by Joint Director, SARS, Temsuinla. She stated that the project titled "Gen Pool Conservation of Indigenous

Rice Varieties under Traditional Integrated Rotational Farming System (Jhum optimization) for Promoting Livelihood and Food Security as Climate Change Adaptation Strategy in Nagaland" was launched in April 2019 with the Ministry of Environment, Forests & Climate Change, Government of India as the funding agency. She further highlighted that the project was implemented in five districts of Nagaland covering 22 villages and benefiting around 1000 families.

Various agenda were discussed in the meeting including extension of the project period. APC, Kikheto Sema, IAS explained that the project was for a period of three years, however the project could not be implemented on time due to delay in release of fund, the total lockdown due to COVID-19 and prolonged dry spell which has affected standing crops in some districts. He therefore sought approval from the house to request the Ministry to further extend the project period till March 2022 to

complete the project, to which the house agreed.

The NAFCC Project in Nagaland aims to undertake baseline survey for targeting of Jhum area, facilitate treatment @ 1 ha of Jhum area per family, develop germplasm of traditional rice varieties and other indigenous crops, promote cultivation of indigenous varieties of rice in 1000 ha area, establish 100 vermicomposting units, etc. For promoting water use-efficiency and its conservation, gully plugs, loose boulder check dams, bench terraces and land levelling works would be undertaken.

The projects under NAFCC prioritizes the needs that builds climate resilience in the areas identified under the SAPCC (State Action Plan on Climate Change) and the relevant Missions under NAPCC (National Action Plan on Climate Change) and National Bank for Agriculture and Rural Development (NABARD) is the National Implementing Entity (NIE).

# 4th PROJECT STEERING COMMITTEE MEETING OF FOCUS HELD

The 4<sup>th</sup> Project Steering Committee meeting of Fostering Climate Resilient Upland Farming System in North East (FOCUS) – Nagaland was held on 12<sup>th</sup> August 2021 at the Secretariat Conference Hall, Kohima.

Chief Secretary Nagaland, J. Alam, IAS appealed the Agri and Allied Departments and all concerned departments to contribute towards making the FOCUS project a success. He stated that the project has the potential to have a positive impact on the farmers across the State.

APC and Mission Director, FOCUS, Kikheto Sema, IAS while giving a presentation on the project activities stated that project is designed to provide farmers with better jhum cultivation practices that will be both more productive and more sustainable, thus creating an ecological balance, enhancing resilience to climate change, and raising farmers' incomes, support improved market access and

value chain development as farmers move to more market-oriented production. The overall goal of the project is to increase agricultural income and to enhance resilience to climate change. This would be achieved through the development objective of increasing the environmental sustainability and profitability of farming systems practiced by highland farmers.

Various agenda discussed at the meeting included inclusion of three new districts in FOCUS project. With the creation of Noklak as a new district and with the World Bank projects in Tuensang and Peren having winded up during 2019-20, it was felt genuine to propose for inclusion of the three districts to FOCUS for the remaining three years of the project implementation. The Project Steering Committee agreed to submit the proposal for inclusion of the three districts to Directorate of Economic Affairs. Gol.

# NSRLM DISBURSES Rs. 98 LAKH TO 75 SHGs

In solidarity with the State Government in celebrating the 75<sup>th</sup> Anniversary of Indian Independence 'Azadi Ka Amrit Mahotsav' from 1<sup>st</sup> July to 14<sup>th</sup> August 2021, Nagaland State Rural Livelihoods Mission (NSRLM), Rural Development

in collaboration with Nagaland Rural Bank (NRB) disbursed a loan amounting to Rs. 98 lakh to the 75 Self Help Groups on 13<sup>th</sup> August 2021.

On the occasion, Joint Secretary, RD and Mission Director, Imtimenla stated that the State

Mission objective is to bridge the trust between banks and the poor and added that the State Mission and the banks have contributed equally to make the SHG members "Credit Worthy" over the years. Imtimenla said that the State Mission is encouraged by the NRB's Chairman proactive initiative in providing the loans to the SHGs. She informed that currently, there are 246 SHGs accessing financial services from NRB and expressed hope that the joint effort will continue to increase financial service coverage and bring change in the lives of the poor and marginalised.

Chairman, Head Office, NRB, V. Venkata Narayana expressed his confidence in the credit worthiness of the SHGs. He noted that timely repayment of the SHGs is appreciable and that NRB will continue to support access to credit linkage to eligible SHGs.

Chief Operating Officer (COO-Programs), NSRLM, M. Rollan Lotha conveyed that the State Mission has established strong Community Based Recovery Mechanism (CBRM) committee in banks

where SHGs are transacting. The committee comprises of the Bank Manager and the SHGs cadres wherein the committee ensures access to loans by the SHGs and their timely repayment to the banks. To access the loan, each SHG member develop their Household Investment Plan (HIP) which is consolidated as Micro Credit Plan (MCP) at the SHG level. Regular handholding on building their knowledge and skills for taking up viable livelihoods is imparted to ensure that the plans are credit worthy. The loan provided to the SHGs on the occasion of 75<sup>th</sup> Independence Day by NRB is an encouragement to the rural households and the joint collaboration is a step towards universal coverage of Financial Inclusion in Nagaland, he stated.

The programme was chaired by SPM-FI, Rajuselie Lhousa and attended by Mission Director, COO-Programs and Imonenla Imkong Phom, SPM-IBCB from the State Mission, while the bank was represented by the NRB Chairman and Bank Managers of NRB branches.

# SENIOR OFFICERS ASSIGNED TO ALL DISTRICTS OF THE STATE TO REVIEW MANAGEMENT OF COVID-19

The State Government with a view to intensively review the steps being taken to manage the COVID-19 pandemic at the district level has assigned a senior administrative officer along with a senior officer from the Health & Family Welfare Department to each of the district in the State. Each team of officers would make visits to their assigned districts and interact with the officials of the District Task Force, the civil society organizations and others to carry out review and guide them in refining/improving the management of COVID-19.

The State Government seeing the need to be prepared for any eventuality of a third wave has decided to continue increasing COVID Testing, vaccination coverage and strengthening of healthcare infrastructure in the districts and hence, the decision was taken to assign the senior officers to make an intensive hands-on

review of the COVID-19 situation in all the districts and to ensure that steps are taken to improve the overall management of COVID-19 throughout the State.

An orientation programme for the assigned senior officers was held on 13<sup>th</sup> August 2021 at the Secretariat Conference Hall, Nagaland Civil Secretariat, Kohima.

Chief Secretary, Nagaland, J. Alam IAS encouraged the teams to take the help of NGOs, Civil Society Organizations, faith based organizations and village authorities in creating awareness among the general public. He further mentioned the need for the teams to make an intensive study and review all aspects in greater detail so as to effectively deal with the COVID-19 situation and most importantly, to ensure that the State improves its preparedness in the event of a third wave.

# NATIONAL FLAG RALLY CULMINATES

The culminating programme of National Flag Rally in commemorating 75 years of India's Independence (Azadi Ka Amrit Mahotsav) celebration was graced by the Director General of Police, Nagaland, John Longkumer IPS at the Police Headquarter, Kohima on 14<sup>th</sup> August 2021.

John Longkumer said that the word Azadi Ka Amrit literally means the nectar of freedom, and mentioned that the Prime Minister of India, Narendra Modi while launching the programme, described it as the 'Elixir of the Energy of Freedom,' the nectar of inspiration from the freedom fighters, nectar of new ideas, new resolutions and total self-reliance which would be an inspiration for the new generations to come. # INDEPENDENCE DAY REPORTS FROM ACROSS THE STATE

#### KOHIMA:

Chief Minister, Neiphiu Rio delivering the 75<sup>th</sup> Independence Day speech at Secretariat Plaza, Kohima on 15<sup>th</sup> August 2021 said, commemorating the milestone and celebrating 'Azadi ka Amrit Mahotsav' (nectar of freedom festival) once again reminded of all the freedom fighters whose sacrifices brought freedom to our people.

Rio said that Made in India COVID-I9 vaccines are helping dozens of countries across the world and as the world's largest democratic nation, India continues to make valuable contributions towards the progress of humanity and for the cause of freedom on an international scale.

Rio remarked that as the country crosses the landmark of 75 years, it is an occasion to celebrate the remarkable contributions of Nagaland and Nagas in the journey of our great nation thus far.

He said that decades since statehood, Nagaland has evolved as a confident state and is a contributing and participating member of India's nation building process. He added that our brave soldiers have fought the country's enemies and guarded our borders with courage and valour. He further added that artists, musicians and cultural ambassadors from Nagaland have added to the vibrant diversity of the country and in the fields of public affairs, bureaucracy, judiciary, sports and the fourth estate, the citizens of Nagaland have served the country with exemplary distinction.

Rio said that as a part of this great country, we continue to be in pursuit of the final solution of the Naga Political Issue, which remains as old as this nation itself. He also said that hopes have risen to a great extent as in recent years as the Naga Political Groups have been in ceasefire with the Government of India for a long time and the peace talks over the

years have made significant progress. He commented that the State Government has over the past years, played the role of active facilitator to the ongoing Indo-Naga political peace talks. He further said that a Parliamentary Committee on Naga Political Issue consisting of all Members of the Nagaland Legislative Assembly and our two Members of Parliament was formed to give further impetus to the peace talks and to help arrive at the final solution at the earliest. He added that a Core Committee was constituted to ensure a focused approach in our role as facilitator, and the Core Committee has appealed to the negotiating parties to move forward with a positive approach of mutual respect and set aside pre-conditions in the greater interest of the people's cry for long term peace. The Chief Minister said the State is unique because of the rich culture and tradition, we need to preserve it and at the same time, we cannot ignore the Modern Art, Music and Literature which is highly respected today, and further, for their promotion in Nagaland, the State Government has announced CM's Scholarship for Music and Arts.

# **CM LAUNCHES 'NAGALAND SDG VISION 2030'**

Chief Minister, Neiphiu Rio launched the 'Nagaland SDG Vision 2030: Leaving No One Behind,' at Capital Convention Centre, Kohima on 17th August 2021. It is a document based on the 17 Sustainable Development Goals (SDG) adopted by the United Nations General Assembly in 2015, while the 'District SDG Localisation & Integration Manual' was launched by Minister, Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu.

Launching the Nagaland SDG Vision 2030, the CM said the document provides with state specific short, medium and long term targets with measurable indicators and strategies that the State should focus on, to meet the aspirations of the people for sustainable livelihoods and living standards.

With North Eastern states, especially the hill states lagging in economic growth and Nagaland, being a resource constrained state, Rio stated that there is hardly any elbow room for the State Government to meet the large investments needed for capital and infrastructure development in the State. He also stated that the rigid implantation norms of most of the development interventions of centrally sponsored/central schemes coupled with the shorter working seasons due to the monsoons, the land ownership system of the State and the comparatively higher cost of transportation, etc. pose big challenges for the State in fulfilling the aspirations of the people.

Adviser, NITI Aayog, Sanyukta Samadar,

IAS addressing the event, said that India can achieve the SDGs only if states steer the entire process of SDGs and become leaders in taking it down to the district, block and village levels, and added that North East Region plays a crucial and strategic role in this. Lauding the State Government for coming up with the document and manual, Samadar expressed hope that with the Steering Committee and coordination among departments headed by Planning Department, the State's position will improve in the coming years. She stated that Nagaland has done remarkably well in clean water and sanitation, poverty eradication, clean energy, sustainable consumption and production, peace justice and strong institutions.

On fund mobilization and financing, Sanyukta Samadar said the Ministry of DoNER and NITI Aayog have come up a collaborative project in developing SDG index for 120 districts in eight NE states which will be launched on 25th August 2021. The index will be used by the Ministry of DoNER as a tool for fund allocation, focusing on critical areas. The Adviser also requested the State Government to make use of the new multi-dimensional poverty index by NITI Aayog, which she said will help with policy planning and targeted intervention.

In SDG performance, Nagaland is ranked 19<sup>th</sup> in the country with a score of 61 and among North East states, it is in 5<sup>th</sup> position. For the SDG performance of districts in Nagaland, Kohima is the top performing district with Kiphire at the last position. In Goal 1 (No poverty) of SDG - 100%

districts are in red category (aspirants, score of less than 50); in Goal 2 (zero hunger) – 81% in green (frontrunners with score of 65-99), 18% in yellow (score of 50 to 64); and in Goal 4 (quality education) – 9% in red, 63% in yellow and 27% are in green category.

Minister Neiba Kronu said that it is important to sensitise, share about the structure on how to work towards the goals with the District Administration and district level departments. He added that the manual contains the necessary

information that are locally relevant in achieving the goals.

Resident Representative, UNDP also spoke on the occasion. Minister, Agriculture and Cooperation, G. Kaito Aye; Advisor, Information Technology & Communication, Science & Technology and New & Renewable Energy, Mmhonlumo Kikon; Advisor, Horticulture and Border Affairs, Mhathung Yanthan; Chief Secretary, J. Alam along with AHoDs and HoDs of concerned departments attended the inaugural programme.

# STATE GOVERNMENT HOLDS MEETING WITH TRIBAL HOHOS

The State Government had a consultative meeting with the Tribal Hohos of the State on 18<sup>th</sup> August 2021 at the State Banquet Hall, Chief Minister's Residential Complex, Kohima.

Chief Minister Neiphiu Rio delivering the keynote address, stated that the long-pending demarcation of the administrative boundary between Peren and Dimapur districts needs to be discussed and settled amicably. He informed that the Government in August 2019 had constituted a Cabinet Sub-Committee headed by Minister of Health & Family Welfare, Pangnyu Phom to meet all the stakeholders, and finalize the boundary between the two districts. The Cabinet Sub-Committee after due deliberations and looking into every aspect and the ground situation, suggested an administrative boundary. However, he said that there have been reservations expressed on the proposed demarcation from people on both sides, citing their customs and traditions.

The Chief Minister said that the 16-Point agreement provided for the Tribal Council to be an appellate authority for customary laws and it would be appropriate for unresolvable matters or disputes and matters involving customs and relating to Naga tribes to be entrusted to a tribal body for resolution. In this connection, the Government decided to entrust the 14 Tribal Hohos of Nagaland to meet and discuss with the tribal leaders of both districts and resolve the matter as per customary practice and in the spirit of brotherhood.

On Naga Tribunal, Rio said that as per the 16-Point agreement, a Naga Tribunal at the state level can act as an Appellate Authority for the cases to be decided according to customary law. Such a tribunal consisting of those who have expertise in customary law can help settle many cases, which are of a complex nature, and which would not be easily decided in modern Courts. He also stressed on the need for documentation and codification of the traditional laws as it will provide clarity on where the traditional laws can be invoked, and where other laws, Central or State Laws, would need to be invoked. With the likelihood of having a separate High Court in the near future, there is a need to codify the customary laws urgently to avoid any possibility of confusion or over-lapping of cases, he added.

Highlighting on the implementation of Register of Indigenous Inhabitants of Nagaland (RIIN), Rio stated there has been discussion on the need to implement RIIN to protect the interests and rights of the Nagas and at the same time, we need to ensure that all rightful citizens of India should not be denied what is justifiably their rights. He added that the decision should be well thought out, and should not cause any panic, chaos or harassment to anyone or community.

On the issue of Women Reservation and Urban Local Body (ULB) elections, Rio said that the Government has not been able to hold elections to the urban local bodies since 2008 and the last effort

to hold ULB elections in 2017 resulted in widespread agitation, and unfortunate incidents, leading to serious law and order problems. Following that, a Cabinet Sub-Committee was constituted in August 2018 to study the problem, and suggest ways to resolve the issue, but it could not make any meaningful progress on resolving this issue. By not holding the ULB elections, Rio informed that the State is deprived of substantial grants under the Finance Commission for under taking various developmental activities.

The Chief Minister highlighting on the institution of Gaon Bura, said the needs of urban settlements are quite different from rural areas and villages. He stated that the nomenclature of Gaon Bura in a town itself is an anomaly and that there is a need to look at the role and need of a Goan Bura in urban areas.

Addressing the gathering, Deputy Chief Minister, Y. Patton dwelled on the matter concerning the demarcation of the administrative boundary between Peren and Dimapur districts. He said it has been adversely affecting the proper administration along the inter-district boundary of both the districts. On ULBs, Patton said due to the inability to come to a consensus on the matter, funds earmarked for ULBs under the Finance Commission Grants have got

suspended and the State is facing grave difficulties in providing basic amenities due to lack of resources. On reservation of women in ULBs, he said that it needs to be looked keeping in view all the aspects concerning history and development of urban centres. On Gaon Buras, Patton said the role and responsibilities of GBs in rural and urban would be different with the passage of time. Therefore, the issues confronting them should be looked in all aspects. On the implementation of RIIN, he urged the state level committee to have some more rounds of meetings and work out the modalities for implementation.

Minister, Geology & Mining, V. Kashiho Sangtam highlighted on the mediation regarding boundary demarcation of Peren and Dimapur districts while role of Gaon Buras was briefed by Commissioner, Nagaland, Rovilatuo Mor. Principal Secretary spoke on Women reservation in ULBs and Secretary, Justice & Law, Ngamjok Konyak highlighted on Naga Tribunals for adjudication as per Naga Customary Law. Principal Secretary, Home, Abhijit Sinha briefed on the implementation of RIIN.

Representatives from the tribal bodies gave their views and suggestions for consideration during the meeting. Elected members from the State also shared during the programme.

John met Mission Director, Aspirational District, NITI Aayog, Rakesh Ranjan IPS at his office chamber in New Delhi to apprise the development project for the Aspirational District, Kiphire on 24th August 2021.

In a press communiqué released by OSD, Planning & Coordination, New Delhi, Thomas Thailu, it stated that during the meeting, Sangtam shared the grievances faced by the rural people of his constituency and requested NITI Aayog to provide more development project to the area. He also shared that many proposals were sent to the ministries but none was sanctioned, for which

Rakesh Ranjan informed that Asian Development Bank (ADB) had sanctioned Rs. 3 crore in February 2020 for Educational Sector, Rs. 5 crore for overall development in January 2021 and Rs. 3 crore for infrastructure sector in February 2021. The total amount meant for development of Aspirational District, Kiphire is Rs. 11 crore.

The Mission Director asked the MLA to send the proposal through the Deputy Commissioner for immediate approval after which the CEO, NITI Aayog will approve the projects and thereafter, it will be sanctioned. Ranjan assured that he will have a virtual meeting along with his colleagues and Deputy Commissioner immediately to see the requirement and issues to be taken.

# **EASTERN NAGALAND LEGISLATORS CALL ON UNION MINISTERS**



The Eastern Nagaland Legislators and DUDA officials called on Union Minister for Ministry of DoNER, Culture & Tourism, G. Kishan Reddy on 25th August 2021 at New Delhi.

During the meeting, on behalf of the Eastern Nagaland Delegation, Minister Pangnyu Phom apprised the Union Minister on the special economic package announced by Prime Minister Narendra Modi during his visit to Eastern Nagaland in the year 2018. Various proposals of the Eastern Nagaland development projects were submitted to DoNER Ministry for early sanction. The delegation also highlighted on the meeting between the NITI Aayog CEO and officials at CEO's Office to remind him about the project proposal submitted to DoNER Ministry.

The delegation also informed the Union Minister that the project proposal is approved by Multi-Disciplinary Committee headed by Ministry of Home Affairs. The delegation strongly appealed to the Union Minister to personally intervene and take up the matter for the interest of Eastern Nagaland

development.

The Union Minister assured to the delegation that he will take up the matter at the earliest in a phased manner and asked the delegation to mention the top priority list for the first phase of the project proposal from the submitted list. He also mentioned that he will discuss with the Prime Minister and other line Ministry for early sanction.

The officials present during the meeting included Joint Secretary, Deputy Secretary, DoNER Ministry and DRC Nagaland House, New Delhi.

Later, the delegation called on the Union Minister for Law & Justice, Kiren Rijiju at his official resident in New Delhi and briefed him about the Prime Minister special package for Eastern Nagaland area. They had requested him for kind intervention and support. The Union Minister responded positively and said that he will meet the DoNER Minister and other colleagues to support the project submitted to the Ministry of DoNER to get through on time.

# ABHIJIT SINHA HOLDS MEETING TO REVIEW MANAGEMENT OF COVID-19

A review meeting with senior officers who were assigned to all districts of the State to review the management of COVID-19 was held with Principal Secretary, Home, Abhijit Sinha, IAS at the Secretariat Conference Hall, Kohima on 26<sup>th</sup> August 2021.

The major concern of the officers who were assigned to various districts was the low turnout for vaccinations. They viewed that the main challenge in achieving vaccination was due to vaccine hesitancy in the minds of the people.

It was observed that awareness campaign on the COVID vaccines needs to be boosted especially in the rural areas. Further, there is a need to sensitize community leaders, NGOs, GBs and faith based organizations should be done at the earliest. It was also suggested that misinformation and fake news needs to be addressed rationally and logically, while write ups or videos in local dialects countering the viral fake news should be prepared and disseminated to the people.

The officers gave a brief update on the situation of their assigned districts and actions suggested to improve the overall management of COVID-19 throughout the State.

The State Government seeing the need to be prepared for any eventuality of a third wave has decided to continue putting stress on COVID testing, vaccination coverage and strengthening of healthcare infrastructure in the districts.

# HORTICULTURE DEPARMENT FLAGS OFF WINTER VEGETABLE SEEDS DISTRIBUTION

Advisor, Horticulture and Border Affairs, Mhathung Yanthan, flagged off the distribution of winter seeds under MIDH 2021-22 and NEC 2020-21 on 26<sup>th</sup> August 2021 at the Directorate of Horticulture, Kohima. It was distributed to identify villages for COVID-19 post pandemic economic recovery activities.

Speaking as the special guest, Yanthan said that Nagas have learned great lessons during the pandemic, to produce enough for ourselves and enough for marketable surplus so that we get economic returns. Keeping in view of this, the Chief Minister has taken the initiative and this programme has been conceptualised, he stated.

Yanthan said that Nagaland has enough surplus production but no proper market or proper post-harvest technology and no market channelizing. He further mentioned that the farmers have to be encouraged to do farming in real business venture and consider themselves as entrepreneur, for which the Department has to extend their service effectively to the farmers. He also called upon the Department and farmers to take advantage of the air cargo facility which is now available for all.

Agriculture Production Commissioner, Y.

Kikheto Sema IAS, in his introductory remarks, acknowledged the Department for working tirelessly for the farming community at the time of pandemic and arranging the winter seeds in advance to the farmers covering 170 village. The ACP also requested the farmers to preserve the seeds for future use.

Under funds provided by NEC for the year 2020-21, the Department provided quality vegetable seeds to the farmers for whole year cultivation, identifying 100 vegetable villages covering 11 districts including 10,000 households and under MIDH during 2021-22, 1,000 Ha area is to be covered under vegetables wherein villages are adopted as 'Vegetable villages' by the Department and are supported with vegetable seeds for both kharif and rabi season. So far, there are over 70 vegetable villages covering all the districts including the youngest district of Noklak. The concept behind these 'Vegetable villages' is to increase the quantum of vegetables produced so that there is marketable surplus which can contribute to increasing income of the villagers by way of sale of the vegetables while also contributing to their nutritional security by ensuring availability of vegetables for their consumption.

## UNION MINISTER OF STATE VISITS NAGALAND



Union Minister of State for Tribal Affairs, Government of India, Renuka Singh reviewed the progress of the on-going projects sanctioned by the Ministry of Tribal Affairs to the Government of Nagaland under Article 275 (1) of the Constitution of India, Special Central Assistance to Tribal Sub-Scheme, Eklavya Model Residential Schools (EMRS) and Tribal Research Institute (TRI) in its meeting held at Hotel Japfü, Kohima on 26th August 2021.

The meeting was chaired by Home

Commissioner, Abhijit Sinha IAS, and was attended by senior officers. During the review meeting, the Union Minister was apprised of the decision of the State Government on creation of the new department of Tribal Affairs by the State Cabinet on 5th August 2019 and the activities being carried out by the Tribal Affairs Department and DUDA.

The Union Minister also called on Chief Minister, Neiphiu Rio along with some of the Cabinet/Advisor at his official residence in Kohima.

# **NSACS CONDUCTS ONLINE TRAINING**

A two-day online Training of Teachers under Adolescence Education Programme (AEP) was held on 25<sup>th</sup> and 27<sup>th</sup> August 2021. The training was conducted by the Nagaland State AIDS Control Society in coordination with the Nagaland Board of School Education (NBSE), Kohima, Nagaland.

The training was conducted with an aim to enhance the understanding and skills of teachers to effectively address the adolescents at schools and empower them to make healthy choices.

The two-day sessions comprised of different topics such as HIV/AIDS and STI, Growing up and Adolescence Reproductive Sexual Health,

Current HIV scenario and prevalence in Nagaland, Overview of AEP in India and some best practices in other states, Mental Health and Substance Abuse, Life Skills for HIV prevention. The resource persons were Sonal Walia, Consultant (IEC & MST), NACO, New Delhi; Metevinuo Sakhrie, Joint Director (IEC), NSACS; Thejangunuo Theunuo, Deputy Director (IEC) NSACS; Ainato Yeptho, Deputy Director (SPM) NSACS and Chongkoi Khaming, Assistant Director (MM).

The programme was attended by around 600 teachers of High Schools and Higher Secondary Schools from all the districts of the State.

# COVID-19 AWARENESS PROGRAMME AND VACCINATION DRIVE HELD ACROSS DISTRICTS

#### **TENING:**

Organised by Community Health Centre, Tening under the aegis of Tening Sub-Division Task Force (SDTF) on COVID-19, an awareness programme for shopkeepers, drivers and other stakeholders was held at GHS Auditorium Hall, Tening on 2<sup>nd</sup> August 2021.

MO, CHC, Tening, Dr. Menangtongzuk spoke on various aspects of COVID-19 including vaccine hesitancy and need for more COVID-19 testing, etc.

# SMOKE FREE DISTRICT HEADQUARTER CAMPAIGN LAUNCHED ACROSS DISTRICTS

## **ZUNHEBOTO:**

Zunheboto district launched the Smoke-Free District Headquarter Campaign on 2<sup>nd</sup> August 2021 at Deputy Commissioner's Residence in the presence of President, Sumi Hoho, STH, Town GB's Association and various public leaders.

Chairing the programme, District Nodal

Officer, NTCP, Zunheboto, Dr. Easter Chophy Ngulie highlighted about the aims and objectives of the campaign. She mentioned that according to a survey, out of 23 lakh population in Nagaland nearly 10 lakh are into tobacco habits for which the campaign had to be initiated to protect the future generation. She also briefed about the hazardous

health effects caused by passive smoking, and added that the campaign mainly aims to protect the non-smokers, especially the children.

ANPSA President, Zunheboto Unit, Tokavi Swu expressed his appreciation to Dr. Easter and her team for initiating No Tobacco Campaign earlier at the district focusing on schools and other public places. He added that after organising No Tobacco Clubs at various schools, it has helped and have come a long way in curbing tobacco usage in the district, mainly among the younger generation, which is a positive sign, he added.

Deputy Commissioner, Zunheboto, Peter Lichamo spoke about the disastrous effects of passive smoking and appealed to the gathering to work together sincerely in making the campaign a success. Smoking habits needs to be treated as an emergency situation, keeping in mind the ill effects to our health in general, he added.

#### WOKHA:

The District Level Coordination Committee (DLCC) and District Level Enforcement Squad, NTCP of the District Tobacco Control Cell meeting was held on 2<sup>nd</sup> August 2021.

During the meeting, the committee deliberated on declaration of Smoke Free District Headquarter Campaign and the same was launched after discussing the guidelines and action plan. During the meeting four (4) schools and one college were declared tobacco free educational institutes, namely Pinewood School, Government Middle School (Sector-C), Government Middle School (Sector-D), Santsuo Memorial School and Bailey

Baptist College, Wokha.

Deputy Commissioner and Chairman, DLCC, Wokha, Orenthung Lotha who chaired the meeting appealed to all concerned to work together in order to bring down the percentage of tobacco use in the district. He also congratulated the institutions for the achievement and urged them to be ambassadors of change in spreading awareness about the ill effects of using tobacco.

District Nodal Officer, NTCP, Wokha, Dr. O. Daisy Ovung presenting the quarterly report said, NTCP Wokha has been actively involved in doing awareness campaign by distributing IECs in various locations and providing counselling to patients who uses tobacco at the District Hospital. It also conducted multiple sessions of focus group discussion with tobacco users, providing them with counselling and nicotine replacement therapy support.

## **DIMAPUR:**

National Tobacco Control Programme, Dimapur held the launching programme of 'Smoke-Free District Headquarter Campaign,' which aims to make every District Headquarter 'smoke-free.' The campaign was launched by Commissioner of Police, Dimapur, Rothihu Tetseo with officials from Health & Family Welfare Department and police officers from different Stations at Conference Hall of the Commissioner of Police's Office, Dimapur.

Rothihu Tetseo encouraged all the team members of the District Anti-Tobacco Squad to work with zeal and dedication and to be role models so that the smoke-free campaign would be successful. He also urged the gathering to put up necessary signage in their work places so that people may be made aware about Section 4 of Cigarettes and Other Tobacco Products Act 2003 (COTPA), which bans smoking in public places.

District Nodal Officer, NTCP, Dr. Reyosalu Lase Vizo spoke on the objectives of the campaign and COTPA 2003. She said that the smoke-free campaign is to make the public aware of the hazards of smoking and effects of second hand smoke, which can cause diseases like cancer, stroke, TB,

pneumonia, infertility, etc. Vizo added that the ban on smoking is to protect non-smokers, women and children from second hand smoke.

## MON:

Deputy Commissioner (DC), Mon, Thavaseelan K, IAS on 16<sup>th</sup> August 2021 launched the Smoke Free District Headquarter Campaign at the Conference Room of DC's Office, Mon. The launch was held along with the District Level Coordination Committee review meeting.

Speaking at the launch, Thavaseelan stressed on the importance of making people aware about the harms of second hand smoking (passive smoking) and hoped that through the campaign those people smoking at home would be made aware of the harms that they are causing to their loved ones. He stated that the public should be made aware that it is a crime to smoke in public as per Section 4 of the COTPA 2003.

Nodal Officer, Mon, Dr. I Simon Sumi highlighted some of the aims and objectives of the campaign which includes creating awareness of the harmful effects of smoking and smoking in public places, sensitising people about Section 4 of COTPA 2003, which bans and penalizes smoking in public places and encouraging people to quit smoking. He also laid down the strategies for the campaign such as sensitizing all HoDs, District Anti-Tobacco Squads, regular enforcement drives, advocacy with NGOs, civil societies, churches and schools as campaign ambassadors.

The committee deliberated on the activities for the campaign such as using of leaflets/pamphlets, videos on harmful effects of smoking and legal penalties, posting of signage in offices, institutions and across strategic locations in the town, and choosing the right school for the Campaign Ambassador. With 11 schools in the town declared as tobacco free, the committee also deliberated on making more educational institutions and schools across the district as tobacco free.

## **TUENSANG:**

The launching programme for Smoke Free

Tuensang District Headquarter was held at Deputy Commissioner's (DC) Conference Hall, Tuensang on 17<sup>th</sup> August 2021.

DC, Tuensang, Kumar Ramnikant said that the harm caused by nicotine present in smoking and non-smoking tobacco which causes cancer needs to be made aware among the general public. Smoking tobacco not only harms the primary consumer but also harms the non-consumer, secondary and tertiary individuals around the primary consumer, he said. Smoking tobacco destroys the respiratory system in humans and with the COVID-19 pandemic, those with respiratory problems can be a victim of it, he added. He also asked the Tobacco Consumer Control Cell to expand the campaign to the whole of the district and also establish a habilitation centre for de-addiction of tobacco related substances.

Superintendent of Police, Tuensang, Amit Nigam highlighting on Section 4 of COTPA 2003 encouraged the citizens to cooperate with the police and also help give awareness to the public about COTPA 2003 so that the police can enforce the law successfully.

Dr. Ao Yanger, Junior Dental Specialist highlighted the aims of the campaign to the house. Certificates were also presented to Tobacco Free Schools, St. John Higher Secondary School and Akum Imlong School, and to Tobacco Free Village, Kuthur village.

The launching programme of Smoke Free District Headquarters Campaign-cum- District Level Coordination Committee (DLCC) meeting of District Tobacco Control Cell was held on 27<sup>th</sup> August 2021 at DC's Conference Hall, Kohima.

Addressing the launching campaign programme, Administrator, Kohima Municipal Council, Lanusenla Longkumer stated that the smoke-free campaign is to strengthen enforcement of Section 4 of COTPA 2003 which bans smoking in public places. She suggested the members to implement more stringent enforcement to check illegal smoking, in places such as restaurants, offices and other public places for a smoke-free city. She added that to make Kohima a tobacco-free city, it will require not only involvement of government

agencies but also cooperation from villages, NGOs, police and every individual.

District Nodal Officer (NTCP), Dr. Arenla Walling highlighted the activities of District Tobacco Control Cell. During the programme, Dr. C. Tetseo, Joint Director (Dental) State Nodal Officer declared two villages, Mezoma and Dzuleke as 'Tobacco Free Villages.'

Reviewing the last meeting minutes, Dr. C. Tetseo has suggested the members to install surveillance cameras to keep check of illegal smoking at public places. The programme was followed by discussion on various agenda on Smoke Free District Headquarter Campaign and implementation of more activities for the campaign to sensitize on harmful effects of tobacco in the district.

## TSEMINYU ASPIRATIONAL BLOCK COMMITTEE MEETING HELD

Tseminyu Aspirational Block Committee held a meeting on 3<sup>rd</sup> August 2021 at District Planning & Development Board's Conference Hall, Kohima to discuss on the preparation of its five year action plan for the selected block.

Deputy Commissioner, Kohima and Chairman of the Committee, Gregory Thejawelie informed the members that the Government has notified Tseminyu Block under Kohima district along with other nine blocks spread over the districts as Aspirational Blocks. He said that as per the Government's direction, the District Aspirational Block Committee was constituted with DC as Chairman and DPO (Planning) as Member Secretary along with other 22 officers from various departments as Members.

Discussing on the preparation of the action plan, the meeting deliberated on various implementing programmes under Centrally Sponsored Scheme (CSS) and other programmes undertaken by the departments. The members shared their views and suggestions for the preparation of the action plan. It was decided to work out departmental-wise action plan by each department based on its implementing programmes including schemes under CSS to be incorporated

and to submit it on or before 20th August 2021.

In this regard, DC asked the departmental officers to have required consultation with ADC Tseminyu and respective sub-divisional officers while preparing the action plan and to submit it within the time frame. He said that with the action plan submitted by each departments, the Committee will prepare the final action plan for the selected Aspirational Block depending on its potential and requirements.

ADC, Tseminyu, W. Manpai Phom in his brief note on Tseminyu Aspirational Block, stated that Tseminyu Block with 26 villages was one among the seven blocks under Kohima district. As per the 2011 Census, Tseminyu has a total population of 51,314, including a sex ratio of 1,022 as against the State average of 931, and a healthy literacy rate of 81.71% as against the State average of 79.55%. With a sizeable young population, untapped social capital and human resources, favourable agro-climatic conditions, accessible road connectivity and inherent capacities of traditional village and modern institutions, Tseminyu Block offers immense potential for boosting inclusive growth and development. He also highlighted on the potential of the Block,

infrastructure needs, need for increasing the income of the people in the Block, trade/sector capacity

building requirements and also on the present condition of various sectors in the Block.

# ST. XAVIER COLLEGE, JALUKIE BAGS 'ONE DISTRICT ONE GREEN CHAMPION' AWARD

# AGRICULTURE DEPARTMENT OFFICIALS VISITS KIKRUMA

Officials from the Department of Agriculture along with ATMA, Phek paid a visit to Kikruma village, Phek on 3<sup>rd</sup> August 2021. The objective was to have an interaction with the Village Council and the farmers on the unique farming system being practiced.

A short programme chaired by Deputy Project Director, ATMA, Kohima, Keviu Shuya was conducted, wherein, Joint Director of Agriculture, Dr. I. Amenla, handed over the book 'Innovations in Agricultural Extension' (a joint publication of Michigan State University-Extension-USA &

MANAGE, Hyderabad-India) where the Zabo/Zabü farming system of Kikruma village was also featured.

The officials also handed out copies of ATMA success stories published by ATMA Nagaland and the recently released District Crop Calendar published by the Department of Agriculture along with some winter vegetable seeds. Zanehu, the Farm School teacher and the owner of Razü (Zabo) Farm School of ATMA explained on the Zabo/Zabü farming to the visiting team during a field tour.

# MICRO-ISOLATION ZONE TO BE IMPLEMENTED IN KOHIMA

Kohima District Task Force (DTF) on COVID-19 held a meeting with the representatives of wards and colonies on 4<sup>th</sup> August 2021 under the chairmanship of Deputy Commissioner and Chairman, Kohima DTF, Gregory Thejawelie at DPDB's Conference Hall, Kohima.

DC, Gregory informed the gathering that the meeting was convened to call for concerted efforts from all corners of the district towards the successful implementation of the Micro-Isolation Zone (MIZ), notified by the State Government. He said the concept of MIZ has been conceived with the aim to cause minimal disruption to normal life and economic activities by isolating a defined small geographical area which might be as small as a

building from the rest.

As in Containment Zones, restriction of movement, social distancing, enhanced active surveillance, testing all suspected cases, isolation of cases and intensive IEC on COVID-19 Appropriate Behaviours and other preventive and safety public health measures will be put in place. DC said that depending on the number of COVID-19 cases and number of houses with COVID-19 cases, a cluster of houses or a locality-colony/block/khel/ward/ village will be declared as MIZ.

In this connection, the DC called for collective efforts from all the wards and colonies to join hands and assist the DTF in identifying the household and provide required information to

implement the exercise effectively so as to break the chain of transmission. While appreciating the AKMWP, wards and colonies for extending their best cooperation and efforts in containing the spread of the disease so far, the DC further solicited their continued support and effort. He said the second wave is not over yet and the prevailing positivity rate and the risk associated with the impending third wave is of great concern where the district needs to

scale up testing and vaccination and urged them to put more efforts in these areas.

CMO, Kohima, Dr. Vezokholu Theyo spoke on the testing strategy and also emphasized on the importance of testing and vaccination in the present scenario of the pandemic. DIO, Kohima, Dr. Rupert Peseyie also informed that the percentage of vaccinated beneficiaries has improved after the sensitization programme conducted by the DTF.

#### MOKOKCHUNG:

The duration of engagement for JJM work is from 2020-2025.

Er. Imnazulu Ao also highlighted on the function of DWSM. At the district level, DWSM is responsible for overall implementation of water supply and sanitation. DWSM is headed by Deputy Commissioner as Chairperson, and he further pointed that DWSM was formed during 2003 and is functional till date.

Chief Medical Officer, Wokha replying to queries raised by Chairman, DPDB, Wokha, Mmhonlumo Kikon replied that the district has intensified random testing and special vaccination drive during the previous two/three weeks. He also informed that the district has witnessed an increase of 752 numbers in testing, while 1000 increase in numbers of vaccination. The CMO further informed the Chairman that several action plan is being worked out to increase the level of awareness and

sensitization in the district.

The main objective of the exercise is ODF Plus sustenance, focusing mainly on the management of solid and liquid waste, plastic

During the exercise at Tening village, SDO (PHE) Tening Block, Engineer, Volie Rentta spoke about the objectives of Jal Jeevan Mission (JJM) which is under the Ministry of Jal Shakti. He said that JJM is based on community approach to water and envisages supply of 55 litres of water per person every day to every rural household through Functional

Household Tap Connection (FHTC) by 2024. He also appealed to the community to contribute 5% to the mission through community participation as per the JJM guidelines, to achieve the target.

District Coordinator-cum-IEC Consultant, DWSM, PHE, Peren, Binsaniu Rentta also spoke on JJM and encouraged the community to work together with the Department in implementing and successfully finishing the project at the villages on time. # PWD (R&B), PEREN:

Celebrating the 'Azadi Ka Amrit Mahotsav,' Public Works Department (Roads & Bridges), Peren Division organised a District Rural Road seminar on 15<sup>th</sup> August 2021 at DC's Conference Hall, Peren with Advisor for Animal Husbandry & Veterinary Services, Women Resources Development, R. Khing as the special guest.

Speaking at the programme, the special guest stated that Pradhan Mantri Gram Sadak Yojana (PMGSY) was launched on 25th December 2000 with the primary objective to provide connectivity with an all-weather road (with necessary culverts and cross-drainage structures, which is operable throughout the year), to the eligible unconnected habitations in the rural areas with a population of 500+ in plain areas, 250+ in

North-Eastern and Himalayan states and 100+ in the critical Left Wing Extremism (LWE) affected blocks (as identified by MHA), as per Census 2001, so that people in the rural area have access to basic health services, education and market for their produce.

R. Khing said that the Government of India subsequently launched new interventions/verticals namely PMGSY-II for upgradation of 50,000 km of road length, Road Connectivity Project for Left Wing Extremism Affected Areas (RCPLWEA) for construction/upgradation of strategically important roads and PMGSY-III for consolidation of 1,25,000 km of routes and major rural links connecting habitations, inter-alia, to Gramin Agricultural Markets (GrAMs), higher secondary schools and hospitals. The implementation period of PMGSY-III is till March 2025.

Further, R. Khing added that in Nagaland, since the inception of the project, till July 2021, a total of 4,382.05 km road length has been sanctioned under PMGSY-I and against 116 eligible habitations identified for coverage under the scheme, 109 eligible and feasible habitations under the scheme and seven under various State schemes are provided with all-weather road connectivity.

Under PMGSY-II, a total of 227.60 km road length has been sanctioned and are at various stage of completion. Overall, 2,932.83 km road length has been completed under various verticals of the scheme as on 31/07/2021. Additionally, 53 number of bridges were also sanctioned under the scheme so far, out of which 21 bridges are completed with another 20 bridges at launching stage.

The projects sanctioned under PMGSY-I and II will be winding up by August 2022 and all the works are expected to complete by 31st March 2022.

The programme was chaired by EE, PWD (R&B), Peren Division, Dr. Khuito Murumi and a technical paper presentation on the topics - Use of new technology in rural road construction, Implementation of PMGSY-III scheme, and Role of PMGSY in development of respective rural areas, was presented by SDO, PWD (R&B), Peren Sub-

Division, Er. Asembe Mbungcha.

## KOHIMA DPDB MEETING HELD

Kohima District Planning & Development Board (DPDB) meeting was held at DPDB's Conference Hall, Kohima on 16<sup>th</sup> August 2021 which was chaired by Deputy Commissioner (DC) and Vice Chairman, Kohima DPDB, Gregory Thejawelie in the presence of Advisor for Urban Development and Municipal Affairs, Dr. Neikiesalie Kire.

The meeting reviewed the last meeting minutes, and the DC reminded and requested all Village Adoption Committees to chalk out its programme and to start the process at the earliest.

work out the detailed project proposal for approval by DPDB and for onward submission to the Government.

Other concerns such as the exercise of unregulated water pipeline and plastic free within Kohima town were also taken up during the meeting, and it was decided that activities in clearing the unregulated pipeline in the worst affected areas and checking of prohibited plastic items will be looked into and action will be taken in due course of time. In this connection, a committee for streamlining the water pipeline was also constituted during the meeting.

Senior Treasury Officer, Kohima, Vechiso Chakhesang gave a PowerPoint presentation on the structure of government accounts, classification of accounts, learning to read-demand for grants and the index of classification.

# **COVID-19 SOP IN NAGAMESE RELEASED**

#### DIMAPUR:

Deputy Commissioner (DC), Dimapur, Rajesh Soundararajan, IAS on 16<sup>th</sup> August 2021 released the COVID-19 SOP in Nagamese on COVID-19 Containment and Management, issued by the Ministry of Panchayati Raj, Government of India, for peri-urban, rural and tribal areas at DC's Conference Hall, Dimapur. The function was attended by officials and staff of DRDA, Dimapur led by Project Director, Kethosituo Sekhose and officials of District Administration along with the ADC,

Dimapur.

The DC in his speech remarked that providing copies of the SOP in a local dialect may seem small but it will go a long way in educating the masses, particularly in the rural areas. He extended his appreciation to the DRDA, Dimapur for this innovative and life-changing work.

Project Director, Kethosituo in his welcome address expressed gratitude to the PO, DRDA and all staff who were involved in the translation. He also stated that this SOP has been tuned by the Ministry

of Panchayati Raj which was originally issued by the Ministry of Health & Family Welfare.

#### KOHIMA:

The Kohima District Task Force (DTF) on 17<sup>th</sup> August 2021 culminated the exercise of information dissemination on COVID-19 in vernacular with Deputy Commissioner, Kohima, Gregory Thejawelie releasing the Nagamese brochure, which will be in soft copy version for social

media platforms.

The Kohima DTF, through the IECC has also brought out the information brochures on COVID-19 in Tenyidie and Rengma local dialects, which comprehensively covers all COVID-19 related information relevant till date. The DTF has so far printed out 5000 copies in Tenyidie and Rengma dialects, which have been distributed to the public through the village councils and faith based establishments under the district.

## **NOKLAK DPDB MEETING HELD**

Noklak District Planning & Development Board (DPDB) meeting was held on 17<sup>th</sup> August 2021 at Deputy Commissioner's (DC) Conference Hall, Noklak under the Chairmanship of DC and Vice Chairman, Noklak DPDB, Hiazu Meru.

DC, Hiazu Meru requested all the DPDB members to join hands and work together so that Noklak district can go forward in all developmental fronts. Meru sought cooperation from all the DPDB members and he encouraged all the members to give suggestions and innovative ideas.

During the meeting, the board adopted Noklak town and agreed to pull in resources available in their respective departments for the upgradation of the town. Formation of Officers' Club at Noklak town was discussed and a committee under the chairmanship of DC was resolved, the formation of which the board felt, is necessary to enhance coordination among the officers posted at Noklak.

The board formed a committee for preliminary case study on scrub typhus, typhoid and peripherial neuritis which are very common diseases in the region. The committee is comprised

of EAC, Noklak, B. Pukha Lam; Medical Officer, CHC, Noklak, Dr. Chongya and SDO, PHE, Noklak, Er. Khaoshai Lam.

For public utility and facilities, proposal for operating/running a local taxi service in Noklak was deliberated, which the board believes will serve as an opportunity to the unemployed youths for their livelihood and also for easy transportation of the people. The board decided that a Rate Fixation Committee shall fix the rates. NST bus service from Noklak to Kohima and Dimapur was also discussed during the meeting, and the board approved and recommended it to the higher authority for consideration.

SDO (C), Thonoknyu, Longdiba Sangtam informed the board regarding the road condition of Thonoknyu sub-division where he highlighted that both the roads connecting to Thonoknyu sub-division from Tuensang and Noklak, which is the lifeline of the sub-division is in a deplorable condition due to continuous rain, and to this, the board deliberated and agreed to apprise the concerned department.

# SENIOR GOVERNMENT OFFICIALS VISIT DISTRICTS

#### KIPHIRE:

Commissioner & Secretary, Rural Development, Neposo Theluo along with a medical team led by the Deputy Director visited Kiphire on 19<sup>th</sup> August 2021. The meeting was held at DPDB's Conference Hall, Kiphire which was chaired by the Deputy Commissioner (DC) and Chairman, Kiphire

District Task Force (DTF), T. Wati Aier.

The DC stated that the medical team and Kiphire DTF are working tirelessly in combating the COVID-19 pandemic and that the DTF has set up COVID-19 Care and medical centres in the district, and it has also decided to award cash to 100% vaccinated villages and CHCs. He said that out of

74,000 population, only 11,750 are vaccinated, excluding the frontline workers. He lamented that people of the district are reluctant to take vaccine especially in villages.

Commissioner & Secretary, Neposo Theluo appreciating Kiphire DTF for their sacrifices and contribution in the fight against the pandemic, informed that their main purpose of visiting the district is to review and check out how the Kiphire DTF is preparing in the fight against the pandemic and to see the requirements in the district. Theluo stated that the State Government is ready to help NGOs and the DTF in extending support to the district in COVID-19 related activities.

CMO, Kiphire, Motsuthung in his brief report stated that the medical team is conducting special vaccination camp and random testing from time to time at Kiphire town and the villages. He also informed that during the Independence Day celebration, seven villages were awarded for securing 100% vaccination. He lamented that people are not coming forward to get vaccinated and not even a single person has been vaccinated in eight villages.

During the meeting, the team had discussion with the tribal hohos, church and student leaders and NGOs on the following agenda - reluctance of the people to get vaccine, for which church leaders have been entrusted to create awareness on the benefits of vaccination; to enhance the COVID-19 fund for Kiphire Aspirational District; requirement of one gynaecologist and X-ray Lab Technician; shortage of doctors and nurses in District Hospital Kiphire, for which higher authority have been requested to solve the problem at the earliest.

The Kiphire DTF also decided to reopen

Class XI and XII following the State Government SOP, strictly with 50% attendance and online classes will continue till Class X.

#### **MOKOKCHUNG:**

A review meeting on COVID-19 status of Mokokchung district was held on 20<sup>th</sup> August 2021 along with the State Nodal Officer on COVID-19 at ADC's Planning Conference Hall. The meeting was held under the chairmanship of Deputy Commissioner and Chairman, Mokokchung District Task Force (DTF).

Addressing the gathering, Joint Secretary, Agriculture and State Level Monitoring Team COVID-19, Sachin Jaiswal lauded the efforts of the Mokokchung DTF for achieving good coverage of vaccination in the district. While discussing on the COVID-19 status he said, the priority area should be COVID-19 testing, strengthening of monitoring and contact tracing. He also suggested to increase the average of contact tracing and added that efforts can be made to achieve 100% vaccination for those villages who have achieved 90%, for low vaccine coverage area below 50%, the District Task Force was encouraged to put more effort.

Joint Director, Health & Family Welfare, Dr. Kika Longkumer stressed on the importance for monitoring of patients under home isolation and timely testing/treatment.

Sharing on the district's activities on COVID-19, CMO, Mokokchung, Dr. Chubala Aier said that the Department is doing its best to improve the overall activity related to COVID-19.

#### PEREN:

State Level Monitoring Team of COVID-19 led by Mohammad Ali Shihab, IAS with senior officials from Health & Family Welfare Department, visited Peren on a four-days visit, from 20<sup>th</sup> to 23<sup>rd</sup> August 2021.

A meeting was convened at Peren Town Hall on 20<sup>th</sup> August 2021. In his address, Ali emphasized on the need for testing, tracking, treatment and vaccination. He appealed to the healthcare workers to monitor the entire activities of

the district and also asked them to share their views and suggestions and sought for their support and cooperation. Further, he urged the health workers to give their best effort in their job.

Deputy Chief Medical Officer, Dr. Thomas gave a PowerPoint presentation on COVID-19 patient diagnosis, treatment, vaccination, sensitization of pandemic and statistic reports of the district.

The Task Forces from different blocks also had an interaction session with the State Level Monitoring Team of COVID-19 where they shared their experiences and the grassroot situation. The members said that many people did not come forward for vaccination due to rumours spread on social media. Church leaders and womenfolk were urged to educate the people in a positive way.

Principal Director, School Education and member of the State Task Force, War Room, Shanavas C in-charge of Zunheboto district, accompanied by Deputy Director, Health & Family Welfare, Dr. Nitovi Shikhu visited Zunheboto on 20<sup>th</sup> August 2021 and held a meeting and interaction with Zunheboto DTF, administrative officers, Sumi Hoho and other leaders, involved in the fight against the COVID-19 pandemic.

Shanavas while acknowledging the Zunheboto DTF said that the War Room has been monitoring every district closely and Zunheboto district have the credit of a well-organised team in the DTF and properly administered medical team under CMO and MS with innovative strategies and ways in tackling social issues, creating awareness on the benefits on being vaccinated, appreciable numbers of beneficiaries vaccinated and proper healthcare of COVID-19 patients at the district with other various efforts in handling situations in the pandemic. The team also visited CHC, Akuluto and District Hospital Zunheboto.

Deputy Commissioner, Zunheboto and Chairman, DTF, Peter Lichamo briefed the team on the current situation at the district and suggested on possible changes required in the reporting systems

for districts.

Detailed report on the strategies and policies of vaccination, number of vaccinated and non-vaccinated beneficiaries, aims and targets of the DTF and departments, immediate requirements of DTF, departments and hospital for tackling the other anticipated wave of the pandemic, etc. were presented by District Surveillance Officer, Dr. Hokugha Sema, DTO and in-charge of vaccination, Dr. Aron Muru and Senior Medical Officer, Dr. K. Shikato Sema.

#### **DIMAPUR:**

Secretary, Public Health Engineering, Kesonyü Yhome, IAS who is also the Nodal Officer for COVID-19 management in Dimapur district, held a review meeting with Dimapur District Task Force (DTF) at Deputy Commissioner's (DC) Conference Hall, Dimapur on 20<sup>th</sup> August 2021.

Addressing the gathering, Yhome appreciated the Dimapur DTF for handling the COVID-19 situation effectively in the district till date despite having numerous challenges. exemplary one.

Earlier in the meeting Nodal Officer for COVID-19, Tuensang, Dr. John shared the statistics of COVID-19 status updates of Tuensang district. ES CBLT, Reverend Achu Chang highlighted on the success of extensive vaccination drive in rural areas where he appreciated the contributions of the District DTF, ECS and HoDs.

Mohammad Ali Shihab in his address lauded the Jalukie SDTF and medical fraternity for their collective effort in the fight against COVID-19 situation in the sub-division despite facing numerous challenges. He also extended his appreciation towards various civil societies, frontline workers, faith based organisations and various unions involved for their contribution towards better management of COVID-19 situation in the district.

#### WOKHA:

Wokha District Task Force (DTF) on COVID-19 held a meeting with the State representatives nominated by the State Government, Commissioner & Secretary, Excise and Sericulture, Orenpomo Kikon and Joint Director, Health & Family Welfare (H&FW), Dr. Chekroshuyi

Tetso, at DC's Conference Hall on 23<sup>rd</sup> August 2021.

On the performance of Wokha district to contain the pandemic, Kikon said that the district did a commendable job right from the beginning of the pandemic till today with the district bordering Assam State also. He said that in the first wave, mortality rate of the district was last while in the second wave more than 500 persons lost their lives out of which a few percentage has taken their first dose of vaccination but has also succumbed to COVID-19 and one person who has taken double dose lost his life as he had other related illness. It has rightly proved that taking vaccination protects people from the pandemic, he said. He further added that as the State is expecting the third wave, we have to be prepared to prevent it as it can be very fatal to children, especially to the younger generation, so keeping this in mind the State Government has formed a supervisory board to assist each district to work out a strategy to contain the pandemic.

Joint Director, H&FW, Dr. Chekroshuyi Tetso while speaking on the trend of COVID-19 in the State said that we do not know what will be the situation in a few months if the third wave comes. The State has already lost people from the most productive age group which is 30-60 years during the first and second wave and Wokha district alone has lost 70 persons during first wave. He also added that Wokha district in particular is doing a commendable job in dealing with the COVID-19 pandemic but needs to increase its performance on testing and vaccination so that all the targeted age group gets vaccinated to contain the pandemic.

Deputy CMO, Wokha, Dr. Zuben Kikon presented the status report on COVID-19 scenario in the district. The meeting was chaired by Chairman, DTF and DC, Orenthung Lotha.

#### LONGLENG:

State Level Monitoring Team on COVID-19 led by Commissioner & Secretary, Geology & Mining, K. Libanthung Lotha, IAS along with Joint Director, H&FW, Lhovizotuo Belho visited Longleng and held a review meeting with Longleng District Task Force (DTF) on 23<sup>rd</sup> August 2021 at DC's



Conference Hall, Longleng.

Deputy Commissioner and Chairman, Longleng DTF, M. Shayung Phom chairing the meeting apprised the visiting officers of the current COVID-19 status in the district.

He also highlighted on the strategies applied by the H&FW Department in collaboration with the churches such as vaccination drive in all villages on Sundays, encouraging various leaders to be the forerunner for COVID-19 vaccine and testing drive.

The monitoring team also visited CHC Yachem and Yaongyimchen village and interacted with the Village Task Force. After the meeting, the monitoring team along with DTF visited COVID-19 Hospital and Longleng District Hospital and interacted with Medical Officers led by MS & CMO and visited Namching Health & Wellness Centre.

He also reminded the members to regularly attend DPDB meetings.

The MLA deliberated on various issues pertaining to the development of Longching

#### DC DIMAPUR LAUNCHES COFFEE BAR - NATIVE BREW

Deputy Commissioner (DC), Dimapur, Rajesh Soundararajan, IAS launched the Coffee Bar - Native Brew in the Office of District Project Officer, Land Resources Department, Dimapur on 3<sup>rd</sup> August 2021.

Speaking on the occasion as the special quest, Soundararajan lauded the Department for the initiative while pointing out that there has been an increase in coffee consumption and increase of coffee demand across the globe and country. He noted that with the support of Coffee Board of India, it is the right and opportune time for the Department and the State for increasing coffee plantation and also for improving market linkages and for coming up with coffee processing capabilities. Mentioning that India stands as the 6<sup>th</sup> major coffee producer in the world, where it is being further projected to increase from 15 to 18% from the current level, the DC encouraged the Department to keep up with their awareness programmes and to continue to support the coffee farmers.

Deputy Director, Land Resources who is the Supervisor of Dimapur district, Puvil Kikhi while highlighting on the history of coffee plantation in Nagaland stated that during the early 80s, the Coffee Board of India (CBI) and Government of Nagaland jointly started Nagaland Plantation Crop Development Corporation in 1981. He however said that since CBI could not arrange market for the coffee farmers most coffee plantation farms were abandoned by the farmers except for a few districts like Wokha, Mokokchung, Mon and Zunheboto. He went on to say that during 2014-15, the CBI again had a discussion with Land Resources Department and agreed for taking up coffee plantation whereby an MoU was signed. He informed that presently

8,996 hectares of coffee plantation has been developed in Nagaland where, in the previous year alone 1,003 hectares has been developed in collaboration with CBI.

Spelling out the Department's vision for 2020-30. Kikhi informed that the Department has earmarked to develop 50,000 hectares of coffee and has started the vision in earnest. If we can develop 50,000 hectares, the State would be able to generate a revenue of Rs. 1,630 crore, he explained. Further, he said that till date (2019-20), the Department has exported 27.5 metric tonnes of coffee to a South African company by the name of Noble Cause wherein a memorandum has been signed for 30 years. The company has agreed to buy all the coffee products coming from Nagaland, he added. Kikhi also informed that two of the Department's staff were trained for coffee development from the British Coffee School, Kathmandu. The trainers would be imparting training to the educated unemployed youths across all the districts of Nagaland and the training is scheduled to start from 10th August 2021, so that the youths can set up coffee bars in their respective districts, Kikhi said.

Kikhi also informed that the Department is promoting natural tea including butterfly pea tea, gooseberry tea, sumac tea, fresh ginger tea, rosella tea, cinnamon and moringa tea which according to Kikhi has low cost, can be easily processed and has a lot of health benefits. With the latest initiative of natural tea and coffee which are all organic, the Department has come up with the slogan, 'Drink What You Grow' so that instead of buying from the market, one can grow and drink which is healthier, Kikhi added.

#### **DIMAPUR EXPORTS PINEAPPLES TO KOLKATA**

Molsang Organic Pineapples Producer Company Limited, Molvom, Nagaland in partnership with Agriculture and Horticulture Department, Government of Nagaland, has sent 600 kg of pineapples (500 no. of pineapples in 50 cartons) through air cargo from Dimapur to Big Basket, Kolkata on 4<sup>th</sup> August 2021.

According to a press release by Deputy



Molsang Organic Pineapples Producer Company Limited, Molvom, Nagaland in partnership with Agriculture and Horticulture Department, Nagaland sent 600 kg of pineapple through air cargo from Dimapur to Big Basket, Kolkata on 4th August 2021.

Director, in-charge of marketing, Department of Horticulture, Meya Sashi, Nagaland pineapples are considered as one of the sweetest and juiciest pineapples in the world and certified as 100% organic by OneCert International. He informed that at present, the area under organic certified pineapple cultivation in the State is 850 hectares under Mission Organic Value Chain Development, sponsored by Government of India. The project is being implemented in three villages, namely

Molvom, Bungsang and Mhainamtsi, consisting of 500 farmers. He also mentioned that the production of certified organic pineapple in Nagaland is 10,000 to 12,000 metric tonne with turnover of Rs. 15 crore per year and the Government of Nagaland, Horticulture Department under Mission Organic Value Chain Development – North Eastern Region Vision 2030 is contemplating to create an organic pineapple corridor along the Foothill Road, covering an area of 10,000 hectares.

#### WOKHA DISPATCHES NATURAL RUBBER SHEETS OUTSIDE THE STATE

Land Resources Department, Wokha, Nagaland held a flag-off programme for dispatch of natural rubber sheets from Nagaland at Merapani, (Marachu Yan) Wokha district, on 16<sup>th</sup> August 2021 with Additional Deputy Commissioner, Bhandari, Tiameren Chang as the special guest.

Flagging off the programme, Chang lauded the effort made by the Land Resources Department, Wokha district for bringing recognition to Nagaland as a large scale, high quality natural rubber producing State. He also said that besides bringing economic empowerment and development to the rubber growing community, the State's revenue would also benefit if the Government sets up a streamlined mechanism to check and regulate the outflow of products.

In the programme, District Project Officer, Wokha, Tepunol Yore said that the Department has supported rubber growers under Pradhan Mantri

Krishi Sinchayee Yojana – Watershed Development Component (PMKSY-WDC), IWMP and NABARD funded RIDF tranches, achieving an area of 6,806 hectare and covering 4,135 households in Wokha district till 2020.

DPO highlighted that plantations have covered 123 recognized villages where about 1,557 hectare are being tapped, with about 1,010 households directly engaged in rubber-based activities. Wokha district alone produced about 3,154.20 MT of rubber sheets during the year 2020, generating an income of approximately Rs. 37.85 crore, he added. He also observed that there is increase in reverse migration of people from urban to rural areas to engage in rubber-based economic activities.

After the flagging off programme, a truck load with 65 MT of rubber sheets took off for Aarush Reliable Holdings, Delhi.

# H&FW LAUNCHES INTEGRATED ONLINE HUMAN RESOURCE AND PAYROLL MANAGEMENT INFORMATION SYSTEM

Principal Director, Directorate of Health & Family Welfare (H&FW), Nagaland, Dr. Neikhrielie Khimiao formally launched the web based online Human Resource Management Information System (HRMIS) including Payroll Management System in

the presence of Dr. Vikato Kinimi, Director (Health Services), Dr. Lhouvizotuo Belho, Additional Project Director, Nagaland Health Project (NHP), Dr. Thanghoi Lam, State Programme Officer, NHM and other officials of the Directorate and NHP on 17<sup>th</sup>

August 2021.

The HRMIS system has been developed with the support of the World Bank aided Nagaland Health Project as part of its effort to strengthen public healthcare service delivery in the State. The developed system will be a dynamic repository of health human resources and will help health system digitize recording of key HR functions such as training, transfer and promotion. Moreover, the HRMIS will also digitize and automate the payroll processing of health HR in the State.

Dr. Neikhrielie Khimiao in his address on the occasion emphasized the need of digital tools to make healthcare service delivery more effective in the State, especially in view of COVID-19 pandemic.

Dr. Khimiao also highlighted that Nagaland will be eligible for additional 5-10% of NHM annual budget as per the incentivized plan of the Ministry of Health & Family Welfare with the implementation of the system.

The web-based HRMIS can be used by all employees of H&FW, NHM, and NSACS through a web-based MIS or android application. The link for the integrated HRMIS is available on the H&FW website (www.nagahealth.nagaland.gov.in). Each employee can log in the system using their unique login id, which can be received through SMS on their registered mobile number. Adetailed standard operating process will be made available on the website and communicated to districts in the coming days.

#### DC NOKLAK INAUGURATES OPD CENTRE
