DC PEREN INFORMS

The Deputy Commissioner Peren, Vineet Kumar in a circular has informed all the individuals that the allotment of Patta for the Land in New Site, Peren HQ as per the approval received from the SLAA (First list) is in process. In order to process the allotment to private individuals, the following documents will be required: Aadhar Card, Indigenous Certificate, Survey Map issued by DLRSO, Verification Report from DBs, Treasury Challan (for the amount as per below mentioned rates), Passport Photo (4 nos) and Provisional Allotment Order.

The circular also stated that it is mandatory for all individuals to submit the above mentioned documents for the issue of patta. Failure to provide these documents may result in the rejection/cancellation of the allotment order.

The DC further requested all individuals to ensure that they have the necessary documents ready and submit them at the earliest to the office of the Deputy Commissioner, Peren during office hours.

Payment for Land Premium and Land Rent may be made through the Treasury Office, Peren under the head 0029 and the Treasury Challan in original be submitted to the Office of the Deputy Commissioner, Peren. The Premium Rate (one time) Area: 60x100 = 6000 Sq. fts. Rate=6000x0.20 = Rs. 1200. The Land Rent (yearly) Area: 60x100 = 6000 Sq. ft. Rate=6000x0.10 = Rs. 600.

DC & DISTRICT MAGISTRATE KOHIMA ISSUES PUBLIC NOTICE ON TRANSFER OF GOVERNMENT ACQUIRED LAND

In a public notice issued by the DC & District Magistrate Kohima, Kumar Ramnikant IAS stated that unauthorized transfer of Government acquired land is illegal liable to penal action under relevant section of law. The Notice also stated that private party/parties selling and buying land falling under Government Acquired Land at Lerie and New Kohima College area shall be doing so at their own risk. Therefore the public is advised to report any such dubious land transaction promptly to authority at revenue.dc.kohima@gmail.com.

DEPARTMENT OF TELECOMMUNICATIONS LAUNCHES CHAKSHU FACILITY

Chakshu facility for reporting suspected fraud communications was launched by Minister of Communications, Railways and Electronics & IT, Government of India, Ashwini Vaishnaw on Sanchar Saathi Portal (www.sancharsaathl.gov.in) on 4th March, 2024.

Chakshu facilitates citizens to report the suspected or unsolicited communications received through call, SMS or WhatsApp which are intended for cyber-crime, financial

frauds, Impersonation, fake customer services / lottery offer / loan offer / job offer / installation of mobile tower / disconnection of services or KYC update / loan etc. or any other misuse. Such proactive reporting of suspected fraud communication helps Department of Telecommunications in prevention of misuse of telecom resources for cyber-crime, financial frauds etc.

How to report suspected fraud communications on Chakshu facility:

Following steps are to be followed:

- Visit Sanchar Saathi portal at www.sancharsaathi.gov.in;
- Click Citizen Centric Services and then click on 'Chakshu Report Suspected Fraud Communication';
- Select the medium and category of suspected fraud communication;
- Provide the details of suspected fraud communication. Screenshot of the communication received may also be uploaded which is optional;
- Verify your mobile number with OTP and enter your name;
- · Click submit button to submit the request.

Other facilities available on the Sanchar Saathi Portal:

- i. Block Your Lost/Stolen Mobile (CEIR): CEIR module facilitates tracing of the lost/stolen mobile devices. This also facilitates blocking of lost/stolen mobile devices in network of all telecom operators so that lost/stolen devices cannot be used in India. If anyone tries to use the blocked mobile phone, its traceability is generated; once mobile phone is found it may be unblocked on the portal for its normal use by the citizens.
- ii. Know Your Mobile Connections (TAFCOP): TAFCOP module facilitates a mobile subscriber to check the number of mobile connections taken in his/her name, it also facilitates to report the mobile connection(s) which are either not required or not taken by the subscriber.
- iii. Know Your Wireline Internet Service Provider (KYI): Know Your Wireline internet Service Provider (KYI) module facilitates citizens to check the details of Wireline Internet Service Providers (ISPs). The module enables the citizens to search for presence of any ISP across the length and breadth of the country by entering PIN code, address or name of the ISP.
- iv. Report Incoming International Call With Indian Number (RICWIN): RICWIN module facilitates citizens to report the incoming international calls received with local Indian number (+91-xxxxxxxxxxx). RICWIN enables citizens to be government's eye to report such calls for busting/unearthing suspected illegal telecom setups which cause loss to Government's exchequer and pose threat to national security.

NLA MEMBERS VOICE CONCERNS ON ASSAM HEALING (PREVENTION OF EVIL) PRACTICES BILL 2024

Deputy Chief Minister T.R. Zeliang expressed his concerns over the 'Assam Healing (Prevention of Evil) Practices Bill, 2024' deliberated under Rule 50 during the last day of the fourth session of the 14th NLA at Nagaland Legislative Assembly Secretariat, Kohima on 1st March 2024.

Zeliang emphasized the significance of the discussion on the Assam Healing (Prevention of Evil) Practices Bill, 2024. Emphasizing Nagaland's Christian majority, Zeliang asserted the duty to defend faith and beliefs, citing constitutional provisions safeguarding freedom of religion (Article 25-28). He criticized the Assam Bill, alleging it undermines secularism and targets Christian practices.

Zeliang argued that Assam's diversity mirrors India's secular fabric, emphasizing coexistence among religions in the Northeast. He criticised the Bill's restriction on healing practices by Christian missionaries, asserting healing as integral to Christian faith, protected under constitutional rights.

He condemned religious intolerance incidents in Assam, including detentions of American citizens for alleged Christian preaching and demands to remove Christian symbols from schools. Zeliang urged Assam to revoke the Bill, calling it a threat to India's secular principle. Highlighting constitutional guarantees of religious autonomy, Zeliang urged Assam to respect minority rights and repeal the contentious Bill. He proposed conveying the Assembly's opposition to Assam's Legislative Assembly.

Minister, Tourism and Higher Education, Temjen Imna Along addressed the Assam Healing (Prevention of Evil) Practices Bill 2024 wherein he said that it was within the Nagaland legislature's rights to appeal to the Government of Assam and assert their faith-based practices. He further raised concerns regarding whether this legislation targets a specific minority.

Minister Along urged his fellow lawmakers to critically examine the intentions behind the bill and inquire if it unjustly discriminates against any particular religious group. Emphasizing that the misuse of faith has occurred across religious communities, he reminded the House of the importance of maintaining a fair and inclusive approach. Furthermore, the Minister made a plea to his fellow legislators, urging them not to rush into condemning the bill. Instead, he called for a diplomatic approach, suggesting that they present their concerns and opinions to the Assam Government. Minister Along also took the opportunity to extend his appeal to Christian brothers and sisters residing in Assam, encouraging them to seek guidance from the state's Chief Minister. Underscoring the need for peace, the Minister emphasized that it is a matter of utmost significance not only for Nagaland but also for the entire nation.

The Assam Healing (Prevention of Evil) practices Bill 2024 negates secular ideals enshrined in the preamble of the Indian constitution, said MLA Dr. Sukhato Sema.

Secularism, he added, in India, not only implies existing of diverse religious communities but also separation of religion from state power, therefore if the state infringes on religious freedom of citizens through controversial laws then the fate of secularism is at stake.

This controversial legislation not only jeopardizes religious freedoms but also undermines the concept of unity in diversity that India proudly showcases on the global stage.

Secularism in India, Sema said that it goes beyond mere coexistence of various religious communities; it entails the separation of religion from state power. Consequently, any attempt by the government to impinge on religious liberties through such contentious laws puts the essence of secularism at risk. The call to action now lies with the esteemed legislature to revisit and reconsider the Assam Healing (Prevention of Evil) Practices Bill 2024, specifically addressing the concerns raised regarding the Christian communities in Assam and Manipur.

Sema appealed the August House to project a strong united voice in support of revision and reconsideration of this bill, ensuring the preservation of India's secular

fabric.

Taking part in the discussion on matters of urgent public importance, Advisor for CAWD and Taxes, Kudecho Khamo called the terms used in the Assam Healing (Prevention of Evil) Practices Bill 2024 as incorrect and misleading. He stated that the bill is a direct violation and infringement of the Constitution of India and is against the fundamental principles of secularism. He said that such a divisive policy in the name of religion, caste, etc is against the visions and ideas of the freedom fighters.

Khamoalsosaidthatinsteadofbringing out such a bill, the Assam government should appreciate the contributions of the Christians. He called upon the members of the August House to stand together, promote and inculcate religious tolerance, social harmony and peaceful coexistence. He appealed to the members to reject the bill and take necessary steps to ensure free and fair practices and belief of all religious groups.

LEGISLATORS DISCUSS VARIOUS OUERIES RAISED DURING ASSEMBLY SESSION

Members of the 14th Nagaland Legislative Assembly raised various queries during the fourth session at the Nagaland Legislative Assembly Secretariat, Kohima on 1st March 2024.

Replying to the query raised by MLA, A. Nyamnyie Konyak regarding the status of the Foothill road, Minister PWD (Roads & Bridges), G. Kaito Aye said that the earthwork in formation cutting and embankment of 128 km (single lane road configuration) from Dimapur to Tizit along with one RCC Bridge near Governor's Camp has been completed.

He further informed that the project cannot come under NEC as the project amount is too high for NEC to bear. He however expressed his gratitude to the Chief Minister for allotting an amount of Rs. 148.50 crores out of the State Fund from the budget towards the project.

Chief Minister Neiphiu Rio also supplemented the reply by saying that the Foothill Road project is a concern for the whole State and that his government is fully committed towards making the foothill road functional at the earliest and would work towards bringing more funds from the center. Rio also informed that he would have a consultative meeting with the officials of the concerned department along with the elected members of the areas under which the road passes through to deliberate on how best to move forward with respect to the construction of the road as well as the utilization of the funds allotted.

MLA, A. Nyamnyei Konyak raised a starred question on establishment of Election Office at Tobu and whether the Government is contemplating to create any Election office. He also highlighted about the grievance face by the people of Tobu during election. He questioned as to why the concerned department was facing difficulty to establish an election office at Tobu. Konyak stated how Pughoboto was alloted an election office and Tobu was excluded. Replying to the query Chief Minister assured he will re-examine and do the needful.

On the starred question raised by MLA, Nuklutoshi on the road construction of Foothill Project from Tuli to Niuland NH 61 (2) via Longchem - Champang - Governor's Camp under SARDP - NE Phase - B, Minister in-charge, National Highway TR Zeliang replied that a sum of Rupees one crore forty three lakh forty three thousand has been slated for the said project by the Ministry of Road Transport & Highways, Government of India but also mentioned that the centre suggested to the state government to apply for the given project under PM Gati Shakti Scheme and not under SARDP. He added that the state is now pursuing the sanction for the project under PM Gadi Shakti Scheme.

STATUS OF POWER SUPPLY DISCUSSED IN ASSEMBLY

During the fourth Session of the 14th NLA held at NLA Secretariat, Kohima on 1st March 2024, MLA, Küzholuzo Nienu advocated for the use of thermal and solar energy to address the power shortage in the state. During a discussion on the status of power supply, Nienu suggested that these sources should be explored. In response to the starred question, the Minister in charge revealed that the peak demand is 180 MW, while the state's generation during the monsoon is 21 MW and the average generation during the lean season is 7 MW. Moreover, the state-owned hydroelectric projects currently generate a maximum of 6-7 MW for 10 hours. The Minister also acknowledged that the average shortfall ranges from 14.1 MW to 60.5 MW.

Explaining the cause of the erratic power supply, the Minister in charge noted that the average availability of power from inter-state generating stations and stateowned generation stations is only 138 MW during the monsoon and 110 MW during the lean season. This is significantly lower than the peak demand. Additionally, hydro generating stations are unable to meet their full potential during the lean hydro season (December to April), and several thermal power stations in the region undergo shutdowns for maintenance, reducing the central sector allocation for the state.

also Minister The highlighted inadequate infrastructure in transmission and distribution systems as a contributing factor to the power supply issues. Outdated and overloaded transmission and distribution infrastructure further exacerbate problem of erratic power supply in the state.

During the last day of the fourth session of the 14th NLA at Assembly Secretariat, Kohima on 1st March 2024, Chief Minister & Minister-in-charge, Neiphiu Rio, provided the list of 10 (ten) documents required for obtaining Coal Mining License (CML) in reply to starred question put up by MLA, Achumbemo Kikon on the terms of references for issuing Coal Mining License in the State.

Kikon, taking part in the discussion, said that the required conditions were not fulfilled and illegal mining has become rampant in many parts of the state, which calls for proper scientific mining methods and stringent regulations by the government. He also questioned the low revenue generation from coal mining and the huge revenue gap between 2022-2023 and 2023-2024. The revenue generated by the Department out of the coal mining in the State was reported as Rs. 9,91,82,730/- during 2022-2023 and Rs. 3,41,42,645/- during 2023-2024.

Deputy Chief Minister T.R. Zeliang, cited the high sulphur content of coal from Nagaland which makes it low quality with less profitability. The limited import of coal imposed by the Ministry of Coal led to increase in demand for coal from Nagaland, which added substantial revenue to the state exchequer in 2022-2023, he said. The General Election in January 2024 in Bangladesh, which is a major consumer country of Nagaland coal, and the subsequent availability of cheaper imported coal from

the US and Indonesia led to decrease in demand for Nagaland coal and decline in the revenue generation during 2023-2024, he added. However, the demand for Nagaland coal at both the domestic and export markets are expected to rise, he said.

Minister of Tourism and Higher Education, Temjen Imna Along suggested the establishment of government authorized depots, issuing of license to capital-backed miners only and advance GST bookings to curb non-repayment of GST and preventing exploitation of people and coal resources in the state. He also suggested the Department to initiate capacity building for judicious and maximum profitability of coal mining in the state. MLA, Nuklutoshi said that 45 licenses have been issued legally but the mining operation is being done illegally and hazardously. He suggested bringing in big companies who can ensure proper and ethical mining for the benefit of the people and the state.

Deputy Chief Minister, T. R. Zeliang reiterated that license holders are prohibited from extracting coal through open cast mining and should follow government guidelines. Any discrepancies will be verified by expert team and local MLAs will be invited during the verification process, corrective measures then will be taken accordingly, he said. He also mentioned that designated depots are in operation since 2014 and royalty is to be paid through challans while coal is to be transported through transit pass.

MEMBERS DISCUSS ON RECRUITMENT IN HOME DEPARTMENT

During the last day of the fourth session of the 14th NLA at Assembly

Secretariat, Kohima on 1st March 2024, MLA, Kuzholuzo Nienu, posed a question to Deputy

Chief Minister (Home), Yanthungo Patton regarding the recruitment of constables under the Home Department. Responding to the query, Yanthungo Patton confirmed that the recruitment of constables will be carried out through open recruitment. He provided detailed information regarding the categories of posts, the number of posts to be advertised and the eligibility criteria.

The constable recruitment will include the following categories of posts: Constable (GD), Constable (MT) and Constable (NPTO). While the total number of posts to be advertised in each category is yet to be finalized, the process is currently underway.

Patton mentioned that the eligibility criteria for the recruitment will include the following factors: Candidates must be between 18 to 35 years old. However, there will be a one-time relaxation of age by 3 years, allowing candidates up to 38 years old as of January 22nd, 2024.

Candidates from the general category must have passed Class VIII, while candidates from backward tribes must have passed Class VI. Under physical/medical Standards, the Minister said that candidates will be required to meet the predetermined standards and norms set by the Department.

Furthermore, Patton clarified that the recruitment would not be based on the existing reservation policy but on tribal quotas as per the population ratio.

announcement The open recruitment for constables in the Home department comes as a positive development, providing opportunities for individuals in Nagaland to join the police force. As the recruitment process progresses, the Minister urged the interested candidates to stay updated with the official announcements and fulfill the necessary eligibility criteria to be considered for the positions.

NLA ADOPTS RESOLUTION ON FREE MOVEMENT REGIME ALONG INDO-MYANMAR BORDER

The 14th Nagaland Legislative Assembly passed a resolution on the Free Movement Regime (FMR) along the Indo-Myanmar Border at the Assembly Secretariat, Kohima on 1st March 2024. Deputy Chief Minister, Yanthungo Patton, introduced the resolution on the floor of the house which was moved for consideration and adoption by the August House.

The full text of the resolution on Free Movement Regime (FMR) along Indo-Myanmar Border is as follows:

"Whereas the Government of India has recently announced its decision to suspend the Free Movement Regime (FMR) along the Indo-Myanmar border, and also to fence the Indo-Myanmar border;

And whereas these measures will cause immense hardship and inconvenience, and also agony to the Naga people living in the Indo-Myanmar border areas due to the fact that the traditional land holding system straddles across the international border in many areas, and people have to cross the international border on a daily basis for their normal cultivation activities;

And whereas these measures will seriously disrupt the age-old historical, social, tribal, and economic ties of the Naga people living on both sides of the international border;

Now, therefore, in view of the special

and unique situation mentioned above, this House, hereby, resolves to request the Government of India to reconsider its decision, and to abandon the plan of suspending the FMR and fencing along the Indo-Myanmar border.

The House also resolves to request the

Government of India to work out regulations for movement of people across the borders in close consultation with the people inhabiting the border areas, and for suitably bringing in the village council authorities concerned in the entire system of regulations."

NLA PASSES RESOLUTIONS ON REGULARIZATION OF EMPLOYEES IN GROUP A, B, C & D POSTS

Resolutions on regularization employees in Group A, B, C and D posts appointed prior to 06.06.2016 were passed by the Nagaland Legislative Assembly on the final day of the fourth day of the 14th NLA on 1st March 2024. Leader of the House, Neiphiu Rio moved for consideration and adoption of the resolutions by the House.

The full text of the resolution regularization of employees in Group A& B is as follows:

"Whereas, the State being a welfare State as guaranteed in the Constitution is responsible to provide basic economic security to the citizens and to protect the livelihood of the employees working in any Department,

Whereas, the Cabinet in its decision vide CAB-1/14/2023, dated 9th February, 2024 has resolved to adopt a resolution to regularize Group A & B employees appointed prior to 6th June 2016 and appointed against Gazetted sanctioned posts at the time of their appointment and have completed 10 (ten) years of service under the State Government and whose appointments are not subjudice,

This house unanimously resolves:

To adopt a policy to carry out a onetime exercise for regularization of Group A & B employees appointed on contractual or adhoc basis against sanctioned posts prior to 6th June 2016 and completed 10 (ten) years of service, by conducting a suitability test by which they may be regularized against the post they are occupying provided they fulfill all the criteria as laid down in this Policy".

SPEAKER SHARINGAIN LONGKUMER CALLS FOR SENSITIZATION AND COMMITMENT TOWARDS A RESURGENT NAGALAND

Speaker Sharingain Longkumer shared his reflections on the fourth session of the 14th NLA before adjourning the session sine die at the NLA Secretariat, Kohima on March 1, 2024.

Breaking away from traditional conventions, he offered an apolitical view on the Budget 2024-2025 and the conduct of Members of the august House.

He praised the presented budget as one of the finest before the august House, expressing sincere gratitude to the Chief Minister who is the Minister-in-Charge of Finance for its formulation.

Additionally, he commended the hard work of the officers and staff of the Assembly Secretariat and expressed gratitude to

the media fraternity for their role in disseminating House proceedings to the people of Nagaland. On completion of all the business, Speaker NLA Sharingain Longkumer adjourned the Fourth session of the 14th NLA sine die.

TOT COURSE ON THREE NEW CRIMINAL LAWS HELD

The Nagaland Police under the aegis of BPR&D, MHA organized 5 (five) days TOT course on the 3 (three) New Criminal Laws - the Bharatiya Nyaya Sanhita (BSN), Bharatiya Nagarik Suraksha Sanhita (BNSS) and the Bharatiya Sakshya Adhiniyan (BSA), 2023 commencing from 1st - 6th March 2024 for Police officer from the rank of ASI to Addl. SP, at Rhododendron Hall, Police Complex, Chumoukedima to sensitize the officers and to equip them with a comprehensive understanding of the new laws. The New Criminal Laws shall replace the old laws i.e Indian Penal Code (IPC), 1860 Code of Criminal Procedure (Cr.PC), 1973 and The Indian Evidence Act, 1872.

During the Inaugural Program, the Addl. DGP (Admin) Renchamo P. Kikon IPS gave an overview on the new provisions of the three criminal laws stating that the Indian Criminal Justice System was now poised to be citizen and victim centric while at the same time empowering the police. Various path breaking facets and provisions in the new criminal laws were also touched upon during the address. The Addl. DGP (Admin) encouraged the participants to keep an open mind and diligently participate and be responsive during the course.

Earlier, the welcome note was delivered by Aboli Metha NPS, Principal, Nagaland Police Training School, Chumoukedima and a brief introduction of the course was delivered by Rajashekara N, IPS, Dy. Director BPR&D who is also the main resource person for the training programme. The programme was attended by Khalate Vikram IPS, IGP (CID), Vilhousie Peseyie NPS, Joint Director FSL and 81 Officers from all the District Police of the State.

TRAINING ON FINANCIAL LITERACY UNDERWAY

Nagaland Board of School Education (NBSE) in collaboration with NSE Academy Limited (NAL) have been imparting financial literacy course at the secondary level for the last 8 years (since 2016). The course called Concepts of Financial Literacy has been designed by NSE Academy which will help students in familiarizing about the basics of Finance and Financial Planning and acquire an essential life skill which everyone needs irrespective of jobs, profession, rich or poor in order to make their life better through

management of the financial resources available at their discretion. NBSE and NSE Academy had so far imparted the course to more than 1.5 lacs students in a structured manner. The Board is working to make the course more accessible to all students and it is compulsory for all the students of classes IX and X for the schools registered under the NBSE since 2023 academic session.

NSE Academy conducts training of the new teachers annually, who then teach the course to the students. For the

2024 academic session, an online Train the Trainer program is underway on March 5th & 6th, 2024 for the teachers of class IX and on March 7th & 8th for class X teachers. 364 teachers had undergone the two-day training programme for class IX and 287 teachers are undergoing the training for class X.

Malhar Majumder is the resource person for the training. Currently, he is a partner and promoter of investaffairs.com, visiting faculty of IBS, Kolkata and various other management institutions and Director of Invest affairs Futuristic Pvt. Ltd & Pastel Entertainments and Media Pvt. Ltd. while working in close conjunction with NSE.

Chairperson of Nagaland Board of School Education, Asano Sekhose in the

welcome address urged the teachers to be receptive and learn the components of Financial Literacy in all details from the resource person so the course can be meaningfully transacted to the students. She emphasized the importance of Financial Literacy for everyone, regardless background of students, educators or others.

During the four days training, the resource person will dwell on topics such as money, income and expense, financial planning, banks, making budget etc. to class IX teachers and saving and investments, loans and borrowing, insurance, mutual funds, financial markets etc. to the class X teachers.



Vyasan R informed that over 16,000 polling personnel will be involved in ensuring the smooth conduct of the parliamentary Elections in Nagaland. He urged media personnel to encourage voters, especially first-time voters, to cast their votes and ensure maximum voters turn out.

Commissioner & Returning Officer Nagaland, Sushil Kumar Patel, emphasized the significance of all stakeholders and the media in carrying out the responsibility of the Election process. He highlighted the media as a key ally of the Election commission, informing the public about the ECI's mandate and operations, and educating voters about democracy and Elections.

State Police Nodal Officer, Limasunep, IPS assured that full security measures are in place and will be further enforced according to different situations. He mentioned that several companies of central forces have arrived in Nagaland to assist the state police force in various Election-related duties, including providing security, area domination, setting up check posts, and searching vehicles to enforce the Model Code of Conduct.

Additional Chief Electoral Officer, Awa Lorin, affirmed that the entire Election process is proceeding smoothly and appealed to media houses to disseminate information for free and fair Election.

HIGH-POWER COMMITTEE OF THE NAGALAND FOREST MANAGEMENT PROJECT SOCIETY HOLDS MEETING

The meeting of the High-Power Committee of the JICA assisted Nagaland Forest Management Project Society was held in the Conference Room of the Chief Secretary, Civil Secretariat, Kohima on 27th March 2024.

The objective of the meeting was to review progress of the project and approve the work programme for the coming financial year, 2024-25 and was chaired by the Chief Secretary Nagaland, J. Alam, IAS, who is also the Chairperson of the High-Power Committee. The State Government representatives from the Finance Department, Agriculture the Production Commissioner, PHED, Director, Employment, Skill Development Entrepreneurship and and Secretary, Environment, Forest & Climate Change also attended the meeting. The project was represented by the Project Management Unit, NFMP headed by the Chief Project Director, Dharmendra Prakash.

During the meeting, the progress of the project was highlighted through a PowerPoint presentation. It was highlighted that the project was now in its 7th year and has so far covered an area of 35,082 Hectares in 144 villages against a target of 185 villages and an area of 79,000 hectares. Altogether, 410 Self Help Groups have received revolving funds in the form of loan under the project and it was stated that the repayment of 1st cycle of the loan was 100 % in the first batch villages. The presentation also stated that altogether, around 78 lakh seedlings have been raised and planted and around 18 lakh person days employment have been generated by the project. The work plan for the coming financial year presented the project target of 41 villages covering an area of 9129 hectares. A live demo of the inhouse developed MIS program was presented in the meeting. The Project Management Consultants highlighted the innovations and good practices taken up in the project and also gave a detailed presentation about the potential of forestry projects in the state in the international carbon market.

The Chief Secretary conveyed his appreciation of the MIS program developed by the project and stated that the program could be used by other departments also. He also lauded the Forest Department on the implementation and progress of the project and the efforts made by the project for convergence with other agencies. The Annual Report of the project was also released and the meeting concluded with the Chief Project Director thanking the Chairman HPC and all the other representatives for their support and presence.

NSDMA & DDMAs EXTENDS IMMEDIATE RELIEF

There is a market and scope but people are instead going to money lenders. Shivam, also highlighted on some schemes on education loan which provides 7.5 lakh, Start-up India which gives 10 lakhs with no collateral fees, livelihood mission which gives 50% subsidy, loan facility for agriculture & allied activities, Animal husbandry and housing loan etc, where there is something for everyone who wants to avail. He appealed to the people to avail the opportunity as figures of disbursement is very low and the fund which was allotted lapse. Whenever there is a lapse of fund, it's an opportunity lapse, he stated.

BHANDARI SDPDB MEETING HELD

The monthly Sub-Divisional Planning and Developmental Board of Bhandari was held under the chairmanship of MLA and Chairman SDPDB, Achumbemo Kikon at the conference hall of the Additional Deputy Commissioner, Bhandari on 8th March 2024.

Discussing on advantages disadvantages of communitised system of power consumption and billing method, and enforcing effective system of revenue collection by Power Department, the house reiterated that the department should not be at loss of revenue and that, consumers should be sensitized on responsible and judicious use of electricity power and systematic payment of electricity bills to benefit all stakeholders.

Pertaining to the proposed construction of Bhandari Town Council Office cum Sub-Divisional and Planning Board Conference Hall, the house expressed dismay and stated that there is shortage of land due to which construction of the same is delayed despite urgent need.

Emphasising that Bhandari subdivision is the biggest fish farming bloc of Wokha district, with laden economic potentials, the house resolved to urge the government to establish a Sub-Divisional Fishery Office at Bhandari since it is functioning under DFO, Wokha, currently.

The house also reiterated and urged for the reopening of the SBI Champang HQ branch, to which, Lead Bank Manager, Wokha, informed that logistical survey would be completed by the month of May.

Highlighting on the present state of the Wokha-Bokajan-Road, where the entire Ralan area is stated to be cut off from

the Wokha district Head Quarter, due to washing away of a stretch of road between Yankeli Village and N.Longchum Village, Achumbemo Kikon, along with the PWD (R&B) stated that remedial measures would be initiated as soon as possible to address the grievances of the public of the areas.

TRAINING AND SKILL DEVELOPMENT **UNDER NCAP 2023-24 HELD AT KOHIMA**

A training and skill development of public officials, Government officials and Civil Society organization of Kohima under the National Clean Air Programme 2023-24 organised by the District Administration Kohima was held at DPDB hall, Kohima on 8th March 2024.

ADC Kohima, Rhoseitho Nguoti NCS, in his brief note stated that the National Clean Air programme was launched in the year 2019 and the training was held to disseminate and impart the knowledge to the general public about clean air. He said that it was surprising to learn that the quality of Air in Kohima city was contaminated and does not meet the national standard and added that we have failed to realize that we are all equally responsible for air pollution. He also mentioned that reducing air pollution depends on everybody.

also He said District that Administration has been reaching out to different section of the society, schools imparting the NCAP and called upon all the officers to take up this challenge to achieve clean air collectively.

In the 1st session of the training, resource person JSA, NPCB, Rongsenben Longkumer highlighted on Ambient Air Quality and its Pollution, she stated that under the National Air Monitoring Programme (NAMP) there are 11 manual monitoring stations and 1 CAAQMS station in Nagaland. 7 (Seven) manual stations at Dimapur and 4 (Four) stations at Kohima. She highlighted that the source of Air pollution are mainly from dust raised from vehicular movement on the dusty roads, Vehicular emissions, burning of wastes such as municipal waste bins, garden/leave waste etc., emission from small scale industries such as stone crushers. sand mahals, tyre vulcanization unit, etc. She added that the Central Government launched National Clean Air Programme (NCAP) as a long-term, time-bound, national level strategy to achieve the targets and Centre aims at 40% reduction in particulate matter by 2026. She also highlighted that the average concentration of RSPM for Kohima city for consecutive years i.e from 2020 to 2023 stationed at opposite NST offices has decreased from 75 to 67, while High school junction has increased from 95 to 106, PWD junction from 96 to 71 and upper Midland from 54 to 64.

She mentioned that the air quality of Kohima and Dimapur city has been placed under "non-attainment city" with respect to Particulate Matter and further added that the Local Bodies and Gram Panchayat/Village Councils shall ensure that open burning of Plastic Wastes does not take place.

Resource person, Scientist 'B' NPCB, Yanathung Kithan gave a brief note on the Solid Waste Management Rules, 2016. He said that waste generator shall segregate

and store the waste generated by them; wrap securely the used sanitary waste; reduce solid waste at source, recycle plastic, metal, rubber, and glass by separating them and sending them to recycling for the manufacture of other products.

He further said that no waste generator shall throw, burn or burry the solid waste generated by him, on streets, open public spaces outside his premises or in the drain or water bodies, all waste generators shall pay such user fee for solid waste management, the bio-degradable waste shall be processed, treated and disposed off through composting

or bio-methanation within the premises as far as possible, every street vendor shall keep suitable containers for storage of waste generated during the course of his activity, all resident welfare and market associations shall ensure segregation of waste at source by the generators.

Resource person, JSA, NPCB Y. Hanpong K highlighted on Mission Life.

Later the participants also went for a field exposure trip to KMC waste management facilities. In the second session, ADC chaired that programme and gave a brief highlight of the training to the Civil society organization.

Online Training on Civil Registration System for Registrars of Births & Deaths held for Chumoukedima, Niuland & Dimapur Districts

A day long training programme on the registration of birth and death through the Civil Registration system was organised by District Economics & Statistics department

under Dimapur, Chumoukedima and Niuland District on 8th March, 2024 at Agri. Expo, 4th Mile (Angh House), Chumoukedima.

At the outset, DC & District Chief Registrar of Births & Deaths, Dimapur, Tinojongshi Chang, said that with the advancement of technology, the training is been imparted for switching over to online registration which was done manually. Now with online registration people from anywhere in the world can register.

In addition, he underlined the role of local registers and areas falling within their areas and jurisdiction for the issuance of birth and death certificate to be cautious while filling the form, as once it is enter in the data it will be difficult to re-issue.

He also highlighted the use and purpose of Birth and Death certificate, along with the importance of recording in the occurrence and characteristics of these vital events to enter the exact data, as these records are subsequently used to study the demographic profile and other features.

Addl. Director, Economics & Statistics and Joint Chief Registrar of Births and Deaths, Kohima, Neisatuo Puro in his key note address highlighted that the registration of Birth & Death Act 1969 had been functioning under Nagaland birth & death modules Rule 1999 but the amendments finally came into effect from 1st October, 2023 and is in the process of implementing State Module Rules. He said that with new amendment came into force; birth certificate is the only document as the final proves for death and place of birth.

He informed the registrar to enhance their registration of death, as Nagaland over all birth registration comes to an average of 80000 annually and Deaths registration comes to 3000-4000, which is beyond the actual occurrence, if deaths are not registered it can cause problem in the data set, he added.

Puro also highlighted that with online registration nothing has change, everything will be the same, and it's just a transfer of data in electronic and primary requirement is just a smart phone and internet connection needed. Further, he urged the trainees to properly acquaint themselves with the civil registration system as they are the stakeholders who will implement the system at ground level. In addition, urged the registrar to work with proper dedications for the implementation of civil registration system by furnishing the actual report.

The resource person for the training was Economics & Statistics, Director of Economics & Statistics, Kohima, Chonbeni Patton. Nearly 200 trainees, senior officers from the Directorate office attended the training session. The trainees were imparted training on technical and practical session.

addressing While the gathering Scientist Yanathung Kithan stressed the importance of proper segregation and disposal of dry and wet waste for healthy environment to pave way for concepts of waste management.

He encouraged the gathering to reduce the use of single use products at maximum especially plastic substances and always try to recycle or reuse things other than disposing of, so as to help reduce waste from landfill which will eventually prevent land, water and air pollution. Yanathung urged the gathering to maintain a useful waste bin to deposit waste so that it can be converted into rich organic compost.

The resource person also said that at present 62 million tonnes of waste is generated in the country annually and spoke on importance of duties of various authorities, waste generators, Nagaland integrated waste management policy and its visions and waste management rules and National green tribunal orders.

During discussions on the screening process for society registration, Dr. Yhome proposed the establishment of specific guidelines and criteria to streamline the registration process.

A PowerPoint presentation by the Regional Transport Officer, Kohima, shed light on vehicle licensing and registration. It was revealed that 3580 Learners Licenses and 2747 Drivers Licenses were issued in the current fiscal year. The members deliberated on enhancing road safety awareness and simplifying the registration procedures to make them more user-friendly.

The Divisional Forest Officer, Kohima, provided insights into the Nagaland Forest

National Research Centre on Equines, Hisar, Haryana.

Dr. Keneisezo Kuotsu, Assistant Professor, CoVSc, Jalukie chaired program while Dr. Gunjan Das Prof. & Head welcome the farmers and informed them about the importance of the camp.

As a part of the programme, farmerscientist-interaction was also held which was followed by free vaccination cum Animal Health Camp. In the technical session, Dr. Gunjan Das Prof. and Head and Dr. Bhumapati Devi, Assistant Professor,

delivered lectures on the topics "Important Diseases of Cattle and their management" and "Management of important post-partum Diseases of Pigs" respectively.

Altogether 57 participants (41 farmers and 16 officials) attended the program. Apart from consultation services, free anti-rabies vaccination, mineral mixtures, deworming drugs, antibiotics and other veterinary medicines were distributed to the farmers covering a total of 540 Livestock including poultry.

VERIFICATION OF ARTISANS ON PM VISHWAKARMA HELD AT DIMAPUR

Procedure for Gram Pradhans and ULBs to verify artisans on PM Vishwakarma website was held at DC's office Conference Hall at Dimapur on 19th of March 2024. The programmed was chaired by SDO (C) Dimapur, Yanthungbemo Kikon.

PM Vishwakarma, a Central Sector Scheme, was launched on 17th September, 2023 by the Prime Minister to provide endto-end support to artisans and craftspeople

who work with their hands and tools. The Scheme covers artisans and craftspeople engaged in 18 trades.

Benefits to the artisans and crafts persons include recognition of artisans and craftspeople through PM Vishwakarma certificate and ID card; basic training of 5-7 days and advanced training of 15 days or more, with a stipend of Rs. 500 per day; A toolkit incentive of up to Rs. 15,000 in

the form of e-vouchers at the beginning of Basic Skill Training. It also provides support Collateral free 'Enterprise Development Loans' of up to Rs. 3 lakh in two tranches of Rs. 1 lakh and Rs. 2 lakh with tenures of 18 months and 30 months, respectively, at a concessional rate of interest fixed at 5%, with Government of India subvention to the extent of 8%. Beneficiaries who have completed basic training will be eligible to avail the first tranche of credit support of up to Rs. 1 lakh. The second loan tranche will be available to beneficiaries who have availed the 1st tranche and maintained a standard loan account and have adopted digital transactions in their business or have undergone Advanced Training and Marketing support will be provided to the artisans and craftspeople in

the form of quality certification, branding, onboarding on e-commerce platforms such as GeM, advertising, publicity and other marketing activities to improve linkage to value chain.

In addition, the scheme will onboard the beneficiaries on Udyam Assist Platform as 'entrepreneurs' in the formal MSME ecosystem. Enrollment of beneficiaries shall be done through Common Service Centres with Aadhaar-based biometric authentication on PM Vishwakarma portal. The enrolment of beneficiaries will be followed by a three-step verification which will include Verification at Gram Panchayat/ ULB level, Vetting and Recommendation by the District Implementation Committee and Approval by the Screening Committee.


